I am sending you this email to request permission to pick up our rolling stock equipment at the Rockhill location. I need to pick up several pieces of equipment listed below. On the days that are agreed upon we will arrive on site at 7:00am, I will have two employees arrive on site and prep the water truck to wet down the roads and area that we will be working in. Our truck traffic and equipment traffic will follow a facility-wide vehicle speed limit of 15 miles/hour or less to reduce associated dust emissions. We will have a pre-meeting with all employees and truck drivers to go over the scope of work we plan on doing so all parties are trained in what our responsibilities are. We will wet down the work areas throughout the day. The equipment will be moved from the staging area to the wash area and be washed off with water using the onsite water truck. After the equipment has been cleaned it will then proceed down to the lower area to be loaded onto the lowboys. After the equipment is loaded onto the lowboy the truck will be washed down along with the equipment it is carrying. At no time in the cleaning process will equipment be cleaned using leaf blowers or compressed air. The trucks will be escorted in and out of the quarry as per township agreement. We will be mindful of all roadways to be kept clean at all times. Once all details are in place we will be starting on March 9, 2020 this process could take up to 4 weeks if at that time more time is required we will request additional time from the dep. This is to include, but not be limited to the following.
