Product samples were collected from the recovery well RW-2 (photo 2). There was a RETTEW truck parked at with a water level meter sitting in the newly installed potable well. Recovery well RW-2: The well was opened at 9:51. The following data was collected: PID reading: 275.0 ppm Depth to product: 27.19 feet Depth to water: 27.29 feet Product thickness: 0.10 feet When the passive skimmer system was pulled from the well the containment chamber was 100% filled with product (photo 1). GES collected product samples and emptied the product into a bucket for later disposal. They followed with routine pumping of the recovery well. I departed the neighborhood at 10:15.
