Inspection Purpose: Oversight of supply well installation at complaint inspection at washington Crossing, PA 18977 (Photo #1) and complaint inspection at washington Crossing, PA 18977.							
Weather: Sunny, high 70s/low 80s °F							
PADEP Staff Present: Dustin Lipik, P.G. (DL)							
Narrative: DL arrived at the supply well drilling area at 11:35. Upon arrival DL spoke with Dave Anderson (DA) of Moody and Associates, Inc. (Moody). DA is the professional geologist (P.G.) overseeing the supply well installation on behalf of Energy Transfer (ET). Raab Well Drilling, Inc. (Raab) is the drilling company installing the supply well.							
DA indicates that the borehole depth is currently 675 feet (ft) below ground surface (bgs) and borehole advancement is ongoing. DL notes that Raab's equipment includes a flatwater truck, a large air compressor, an enclosed container for solid wastes, and a liquid waste vacuum truck (Photo #2). A diverter hose is attached at the wellhead to divert rock cuttings in the solid waste container. A separate hose attached to the liquid waste vacuum truck is being used intermittently to remove liquid waste from the containment pad.							
At 11:45, DL speaks with Chris Embry (CE) of Energy Transfer (ET). CE investigated a complaint received on September 22, 2025 from the resident at the resident at the resident that indicated that they observed a truck associated with the supply well installation discharge liquid containing a sheen into a storm drain at the corner of Glenwood Drive and Bruce Road. The resident had provided photos and videos of the discharged liquid. CE had investigated the area prior to DL's arrival and did not see any evidence of staining on the asphalt or sheen on or within the stormwater infrastructure or on the debris within the stormwater drains.							
At 11:49, DL drives to the corner of Glenwood Drive and Bruce Road to investigate the area. DL sees no obvious signs of staining or sheen on the asphalt or stormwater infrastructure and no odors are noticeable (Photos #3 through #6). DL does note that portions of Glenwood Drive and Bruce Road near the storm drain have circular stains (Photo #7), which are consistent with their use as public roadways. DL attempted to speak with the owner of the property of th

At 12:55, DL returns to the supply well drilling area.
At 13:03, DL speaks with DA. DA indicates the borehole is now at 750 ft bgs. DA also indicates that prior to the start of work this morning, the water level within the borehole was greater than (>) 300 ft bgs.
Between 13:06 and 13:09, Raab blows out the borehole to remove cuttings and standing water. Raab continues drilling from 750 ft bgs at 13:09.
At 13:35, Dave Fennimore (DF) of Earth Data Northeast (EDN), Upper Makefield Township's environmental consultant, stops by the drilling area to speak with DL. DL explains the current status of the supply well borehole.
At 13:42, DF leaves Site.
At 14:05, the borehole reaches 800 ft bgs. DA and CE both indicate that the plan for the remainder of the day and is to blow out the borehole and let it sit, possibly overnight, to see how much water enters the borehole. DA indicates that the liquid waste vacuum truck has less than 1 ft of water within the tank indicating that there was minimal inflow into the borehole during drilling. DA notes that the contents of the vacuum truck also include any potable water introduced to the borehole by Raab to cool the drilling equipment.
At 14:10, DL asks Rick Raab of Raab if he or his team had drained or dropped water at the corner of Glenwood Drive and Bruce Road upon leaving the Site on Monday, September 22, 2025. Rick tells DL that Raab staff did not.
At 14:20, DL leaves Site.
