Please find enclosed a Department plan approval to construct, modify, reactivate, or install an air Contaminations source and/or air cleaning device. This plan approval contains special conditions that must be fulfilled. Failure to do so violates Section 127.25 of the Department's Rules and Regulations, which may result in enforcement action and denial of an operating permit.

A Department operating permit will be issued if (1) the special conditions incorporated within the plan approval have all been fulfilled; (2) the Department is satisfied that the project was carried out as proposed in the application, and that the operation of the source(s) and any associated air pollution control equipment conforms with the operational information stated on the application; and (3) the Department is satisfied that the air contaminant emissions from the source(s) comply with the requirements specified in, or established pursuant to, all applicable Department rules and regulations.

This authorization does not relieve the applicant from applying for and obtaining any additional permits or approvals from local, state or federal agencies required for this project. Please be advised that if any other permits are required for this project, they must be issued prior to undertaking the activities described in the permit application. Issuance of the enclosed permit(s) does not indicate an affirmative action on any other pending or future permit applications. If you are uncertain as to whether or not other permits are needed for this project, please use the Department's "Permit Application Consultation Tool" (PACT) which can be found at <http://www.ahs.dep.pa.gov/PACT/>. The online tool is designed to quickly and easily assist potential applicants in determining which types of environmental permits, authorizations or notifications would be needed for specific projects. Based on the user's responses to a series of simple questions, PACT automatically provides an email response with information on permits and other information an applicant should consider.

Any person aggrieved by this action may appeal the action to the Environmental Hearing Board



(Board) pursuant to Section 4 of the Environmental Hearing Board Act, 35 P.S. § 7514, and the Administrative Agency Law, 2 Pa.C.S. Chapter 5A. The Board's address is:
