**ORDER**

NOW, this 20<sup>th</sup> day of July, 2018, the Commonwealth of Pennsylvania, Department of Environmental Protection (“Department”) has made and determined the following:

A. The Department is the agency with the duty and authority to implement, administer, and enforce the Oil and Gas Act, 58 Pa. C.S. §§ 3201-3274 (“2012 Oil and Gas Act”); Section 1917-A of the Administrative Code of 1929, Act of April 9, 1929, P.L. 177, *as amended*, 71 P.S. § 510-17 (“Administrative Code”); and the rules and regulations promulgated thereunder.

B. XTO Energy Inc., is a Delaware business corporation engaged in oil and gas extraction activities in Pennsylvania and has addresses of 190 Thorn Hill Road, Warrendale, PA 15086 and 810 Houston Street, Fort Worth TX 76102 (“XTO”). XTO has identified a mailing address of Corporation Service Company, 2595 Interstate Drive, Suite 103, Harrisburg, PA 17110.

C. XTO is the “owner” and/or “well operator” as those terms are defined in Section 3203 of the 2012 Oil and Gas Act, 58 Pa. C.S. § 3203, of the gas or oil production wells listed in

Exhibit A attached hereto and incorporated herein by reference (collectively, “Wells”, individually “Well”) and the well sites associated with those Wells (“Well Sites”).

D. On January 23, 2018, XTO reported to the Department that 93 Wells, as identified in Exhibit A, did not produce oil or gas during the period from January 1, 2017 through December 31, 2017.

E. Pursuant to Section 3203 of the 2012 Oil and Gas Act, 58 Pa. C.S. § 3203, a well is an “abandoned well” if it “has not been used to produce, extract or inject any gas, petroleum or other liquid within the preceding 12 months.”

F. As of January 1, 2018, and continuing, the non-producing Wells described in Paragraph D and identified in Exhibit A were and are each an “abandoned well” as that term is defined in Section 3203 of the 2012 Oil and Gas Act, 58 Pa. C.S. § 3203, because those wells have not been used to produce, extract, or inject any gas, petroleum, or other liquid within the preceding 12 months.

G. XTO has not plugged any of the Wells identified in Exhibit A. XTO’s failures to plug the Wells constitute violations of Section 3220(a) of the 2012 Oil and Gas Act, 58 Pa. C.S. § 3220(a), which states in relevant part “Upon abandoning a well, the owner or operator shall plug it in the manner prescribed by regulation of the department to stop vertical flow of fluids or gas within the well bore . . . .”, and 25 Pa. Code § 78.91(a).

H. XTO’s failures to plug the Wells constitute unlawful conduct under Section 3259 of the 2012 Oil and Gas Act, 58 Pa. C.S. § 3259, and subject XTO to civil penalty liability under Section 3256 of the 2012 Oil and Gas Act, 58 Pa. C.S. § 3256; XTO’s failures to plug the Wells are a public nuisance under Section 3252 of the 2012 Oil and Gas Act, 58 Pa. C.S. § 3252.

## ORDER

NOW, THEREFORE, pursuant to Sections 3253 and 3258 of the 2012 Oil and Gas Act, 58 Pa. C.S. §§ 3253 and 3258, 25 Pa. Code § 78.88, and Section 1917-A of the Administrative Code, 71 P.S. § 510-17, the Department hereby ORDERS that:

1. **Well Plugging.** XTO shall plug the Wells as follows:
  - a. **Plugging.** The Wells shall be plugged in accordance with the requirements of 25 Pa. Code §§ 78.91-78.98 by no later December 31, 2020.
  - b. **Schedule.** XTO shall, within sixty (60) days of the date of this Order, provide to the Department a schedule (“Plugging Schedule”) to complete the plugging of the Wells by no later than the date set forth in Paragraph 1.a. The Plugging Schedule shall ensure that plugging activities are completed for no less than fifteen (15) Wells in each calendar quarter starting October 1, 2018, and shall include a schedule that provides for plugging of each Well listed on Exhibit A. The Plugging Schedule shall prioritize Wells by taking into account the potential harm that each Well poses to the environment and public health and safety. XTO shall comply with the Plugging Schedule as approved or modified by the Department.
  - c. **Inspections.** XTO shall, within thirty (30) days of the date of this Order, submit the quarterly inspection results for each of the Wells from the last eight calendar quarters. If the results of those inspections are not set forth in detailed inspection reports, including the time, date, name(s) of inspector(s), and description of determinations regarding each Well’s integrity, as set forth in 25 Pa. Code § 78.88(b); or, if XTO does not have quarterly inspection results for each of the Wells, then XTO shall, no later than sixty (60) days after the date of this Order, inspect those Wells without quarterly inspection reports to determine the integrity of each of those Wells and the potential harm that each such Well poses to the environment or public

health and safety (“Inspections”). The written results of the Inspections shall be provided to the Department within ten (10) days after each inspection is performed, and shall include, at a minimum, the time, date, name of inspector(s), and a description of determinations regarding each Well’s integrity, as set forth in 25 Pa. Code § 78.88(b).

d. **Notice of Intent to Plug.** At least three (3) days, but not more than fifteen (15) days before the expected plugging date for each of the Wells, XTO shall submit to the Department a fully completed Form 5500-FM-OG0005, “Notice of Intention by Well Operator to Plug a Well,” and a well location plat for the Well to be plugged.

e. **Plugging Certificates.** Within thirty (30) days after plugging of any of the Wells, XTO shall submit to the Department a fully completed Form 5500-FM-OG0006, “Certificate of Well Plugging,” for the plugged Well in accordance with the requirements of 25 Pa. Code § 78.124.

f. **Well Site Reclamation.** Within one hundred eighty (180) days after plugging each of the Wells, XTO shall completely restore each Well Site in accordance with the requirements of Section 3216 of the 2012 Oil and Gas Act, 58 Pa. C.S. § 3216, and 25 Pa Code § 78.65.

g. **Access.** XTO shall take any and all actions necessary to obtain lawful access to any property that it needs to use to comply with its obligations under this Order. If, despite its prompt use of all lawful means to secure site access to any property necessary to comply with this Order, XTO is unsuccessful in obtaining access, then XTO shall immediately notify the Department and provide documentation to the Department of XTO’s efforts to obtain access.


