Please see our responses below and the associated attachments:

- 1) 8.1A attached for point #19, with SWL's.
- 2) As per our conversation and your follow-up email (also attached for reference), Module 10.14 has been revised to address the powerline crossings; see attached Mod 10, page 4.
- 3) Updated 8.1A's attached.

Note: Based on our recent discussions, it is understood that the only outstanding water monitoring needed at this point is three additional samples for the new point # 31 (the water withdrawal monitoring location on Rhoades Creek). Since the monitoring of this point is only applicable to the proposed water intake, we are requesting that permit issuance not be held up for this additional monitoring and that a special condition simply be added stating that the water withdrawal can not be installed prior to the operator submitting the full six months worth of background monitoring to the Department.

- 4) All ditches steeper than 10% were designed using the protocol listed on page 133 of the PA DEP Erosion and Sediment Pollution Control Program Manual (TGD 363-2134-008). This allows for the cross-sectional area of the void space to be subtracted from the cross-sectional area of the in-channel flow to determine the anticipated flow depth for shear stress calculations, or maximum velocity calculations, if the resulting flow depth is less than 0. All ditches will be regularly monitored for sediment accumulation. Excess sediment will be removed from ditches, as necessary, should the sediment build-up affect the function of the ditch.
- 5) Refer to the attached Mod 1.5 Addendum.

- 2. Module 10.14 Please provide a copy of the agreement letter from the electric utility owner for the proposed road and ditch crossings within the electric line ROW. The letter was omitted from the original submittal. [§86.37]
- 3. Please provide updated 8.1A sheets for sample points 25, 26, 27, 28, 29, 30, 21, and 32 when sampling is complete. [§86.37]
- 4. Module 12 For ditches steeper than 10%, please consider using a minimum flow depth in channel of 0.1 feet and reevaluate rip rap section. The Department has concern with the void space filling with sediment.
- 5. Module 13.5: Please provide a vegetation management plan [§77.531].
