## **NOTICE OF VIOLATION**

Re: PA-04-00740C ECF NOx Emissions Shell Polymers Monaca Potter Township Beaver County

Dear Nathan Levin:

Shell Polymers Monaca (Shell) is authorized to operate pursuant to plan approval PA-04-00740C. Shell reported to the Department that NOx emissions from the Ethane Cracking Furnaces (ECFs) which occurred on several dates in 2024 exceeded plan approval limits, as described in Table 1 below.

The Department has identified the following violations from these events:

PA-04-00740C, Section E, Source G01, Condition #007, states NOx emissions from the ECFs shall not exceed the following:

- 0.015 lb/MMBtu from each furnace on a 1-hour average, during normal operating mode.
- 6.20 lb/hr from each furnace during periods of decoking, hot steam standby, feed in, or feed out.

By emitting NOx in excess of these limits, Shell caused violations of PA-04-00740C and 25 Pa. Code § 127.25.

25 Pa. Code § 127.25 states in part that a person may not cause or permit the operation of a source or control device unless the source or control device is operated and maintained in accordance with the conditions in the plan approval issued by the Department.

The above violations constitute unlawful conduct, and a public nuisance as defined by Sections 8 and 13 of the Air Pollution Control Act (APCA), 35 P.S. Sections 4008 and 4013, respectively. Persons violating DEP's Air Quality Regulations are subject to the penalties of Sections 9 and 9.1 of the APCA. Each day the violation continues constitutes a separate offense.

This Notice of Violation is neither an order nor any other final action of DEP. It neither imposes nor waives any enforcement action available to DEP under any of its statutes. If DEP determines that an enforcement action is appropriate, you will be notified of the action.
