This report provides 12 tabs of hazardous waste LQG information from EFACTS. It allows the user to review LQG hazardous waste generator inspections and information listed below.

This report is used for mid-year and end-of-year reporting to EPA. The Start Date must be 10/1/XXXX and the End Date must be 3/31/XXXX or 9/30/XXXX. A report may be run for a 6 month or 12 month period. For example, 10/1/2016 to 3/31/2017 or 10/1/2016 to 9/30/2017.

- 1. Enter the FY Begin Date.
- 2. Enter the FY End Date.
- Enter All or the Region to review.
- 4. Click on View Report.
- 5. Use arrow keys to move through report tabs.
- 6. The reports can be exported to Excel or CSV.

## Report Tab 1: Active PFSF LQG PFs

Total count, broken down per Region, of active LQG PFs. When PF and/or SF status code is empty, the PF/SF is considered active.

### Report Tab 2: Active PFSF LQG SFs

Total count, broken down per Region, of active LQG SFs. When PF and/or SF status code is empty, the PF/SF is considered active.

## Report Tab 3: LQG Insp Current Year

Total count, broken down per Region, of LQG inspections conducted in the date range entered.

## Report Tab 4: LQG Insp Previous Year

Total count, broken down by Region, of LQG inspections conducted in the previous full FY (10/1/XXXX – 9/30/XXXX).

## Report Tab 5: LQG Insp Current - No Insp Previous Year

Total count, broken down by Region, of LQG inspections conducted in the date range entered but not in the previous full FY.

#### Report Tab 6: LQG Insp Previous – No Current Year

Total count, broken down by Region, of LQG inspections conducted in the previous full FY but not the date range entered.

## Report Tab 7: LQG Insp Current and Previous Year

Total count, broken down by Region, of LQG inspections conducted in both the date range entered and previous full FY.

### Report Tab 8: LQG No Insp Current or Previous Year

Total count, broken down by Region, of LQG inspections not conducted in either the date range entered or previous full FYs.

### Report Tab 9: LQG Insp Previous 5 Years

Total count, broken down by Region, of LQG inspections conducted in the previous 5 full FYs.

# Report Tab 10: LQG No Insp Previous 5 Years - Pharmacy Only

Total count, broken down by Region, of pharmacy LQGs not inspected in the previous 5 full FYs.

# Report Tab 11: LQG No Insp Previous 5 Years - No Pharmacy

Total count, broken down by Region, non-pharmacy LQGs that have not been inspected in the previous 5 full FYs.

# Report Tab 12: LQG Never Inspected

Total count of LQGs never inspected.
