

HAZARDOUS WASTE TSD REPORT INSTRUCTIONS

(Waste_Generators_TSD)

This report provides 11 tabs of hazardous waste TSD information from EFACTS. It allows the user to review hazardous waste TSD inspections and information listed below.

This report is used for mid-year and end-of-year reporting to EPA. The Start Date must be 10/1/XXXX and the End Date must be 3/31/XXXX or 9/30/XXXX. A report may be run for a 6 month or 12 month period. For example, 10/1/2016 to 3/31/2017 or 10/1/2016 to 9/30/2017.

1. Enter the FY Begin Date.
2. Enter the FY End Date.
3. Enter All or the Region to review.
4. Click on View Report.
5. Use arrow keys to move through report tabs.
6. The reports can be exported to Excel or CSV.

Report Tab 1: TSD EPA List

The list of EPA recognized TSD and post-closure facilities used to report TSD inspection data to EPA.

Report Tab 2: All TSD Facilities (Including EPA List)

Total count, broken down per Region, of TSD facilities in EFACTS (including the EPA list of EPA recognized TSD and post-closure facilities).

Report Tab 3: TSD Non EPA Facilities

Total count, broken down per Region, of TSD facilities in EFACTS that do not include the EPA list of EPA recognized TSD and post-closure facilities.

Report Tab 4: TSD Federal Facilities

Total count, broken down per Region, of Federal TSD facilities.

Report Tab 5: TSD Insp Current Year

Total count, broken down by Region, of TSD inspections conducted in the FY date range entered.

Report Tab 6: TSD Insp Previous Year

Total count, broken down by Region, of TSD inspections conducted in the previous full FY (10/1/XXX – 9/30/XXX) but not the date range entered.

Report Tab 7: TSD Insp Current – No Insp Previous Year

Total count, broken down by Region, of TSD inspections conducted in the date range entered but not the previous full FY.

Report Tab 8: TSD Insp Previous – No Current Year

Total count, broken down by Region, of TSD inspections conducted in the previous full FY but not the date range entered.

Report Tab 9: TSD Insp Current and Previous Year

Total count, broken down by Region, of TSD inspection conducted in both the date range entered and previous full FY.

Report Tab 10: TSD No Insp Current or Previous

Total count, broken down by Region, of TSD inspections not conducted in either the date entered or previous full FY.

Report Tab 11: TSD Insp Federal

Total count, broken down by Region, of federal TSD inspections conducted in the date range entered.
