GENERAL REQUIREMENTS

Intent:

It is the intent of this bid specification to describe twenty-two (22) gallon residential recycling bins. The Borough is interested in purchasing two thousand (2,000) of these recycling bins. Bidder shall submit the latest printed specification for the unit bid. Units will be inspected for compliance with specifications upon delivery. Delivery date not to exceed 120 days after receipt of purchase order. Bidder shall also submit warranty papers, invoice, and bill of origin upon delivery. Statement of origin to read NORTHERN CAMBRIA BOROUGH, 1202 PHILADELPHIA AVENUE, NORTHERN CAMBRIA, PA.

DETAILED RECYCLING BIN SPECIFICATIONS

- The body of the bin is composed of recyclable medium or high density polyethylene with a minimum recycled materials content of twenty (20%) percent.
- The capacity of the bin is (minimum) 22 U.S. gallons.
- The bins are forest green, gray or brown in color, as directed by the Borough, and are stabilized against ultraviolet light attack with not less than one half of one percent (1/2 of 1%) UV 531 or equivalent.
- The cart will be hot stamped with "PROPERTY OF BOROUGH OF NORTHERN CAMBRIA," and a Logo as designed by the Borough, on the side of the bin. Stamping will be done in 1" white block letters.
- For a ten (10) year period, the Borough of Northern Cambria may purchase an additional amount of bins each year for continued growth or replacements.

BIN WARRANTY

The entire cart is covered by a ten (10) year, full and non-prorated warranty. The Borough of Northern Cambria will not be charged for any repairs or replacement for any bin during the life of the warranty. Warranty includes, but is not limited to, the factors listed below:

- 1. Damage to the bin body.
- 2. Failure of any plastic component to be resistant to damage in the event of contact with any common household or residential product/chemicals other than those listed by the contractor.
- 3. Failure of any plastic component resulting from rodents.
- 4. Failure of any portion of the bottom of the bin to remain impervious to wear-through after repeated contact with rough and abrasive surfaces.
