

## 2024 PAG-02 Renewal Scenarios

Scenario	Permittee or Applicant Action:	CCD Response:
Existing permittee's PAG-02 coverage expires on 12/7/24 and the permittee does not need to amend coverage before 12/7/24.	Submit 2024 Renewal NOI (3800-PM-BCW0405h) between 8/31/24 and 12/7/24.	Coverage may be approved using effective date of 12/8/24 if approved prior to 12/8/24 and actual date if approved on or after 12/8/24. 1
Existing permittee's PAG-02 coverage expires on 12/7/24 and permittee wishes to amend coverage on or before 12/7/24 OR an amendment NOI is in-house, under review.	Submit 2019 NOI <sup>2</sup> with amendments before 12/8/24. <sup>3</sup>	Receipt of the 2019 NOI requesting an amendment will also be treated as a request to remain covered under 2024 PAG-02; approve coverage under 2024 PAG-02 using effective date of 12/8/24 if approved prior to 12/8/24 and actual date if approved on or after 12/8/24. 1,4
Existing permittee's PAG-02 coverage expires between 8/31/24 and 12/7/24 OR a renewal NOI is in-house, under review.	Submit 2019 NOI or 2024 Renewal NOI to remain covered under PAG-02.	Receipt of either the 2019 NOI or 2024 Renewal NOI will be treated as a request to remain covered under 2024 PAG-02; approve coverage under 2024 PAG-02 using effective date of 12/8/24 if approved prior to 12/8/24 and actual date if approved on or after 12/8/24. 1
Applicant submits an NOI for a new project prior to 12/8/24.	Submit 2019 or 2024 NOI (3800-PM-BCW0405b) before 12/8/24 (applicant's choice).	If applicant plans to begin work prior to 12/8/24 and approval is prior to 12/8/24, approve coverage under 2019 PAG-02 and notify applicant that they must submit a renewal NOI by 12/7/24, otherwise approve coverage under 2024 PAG-02 and post-date the effective date to 12/8/24 (if approved prior to 12/8/24). 1
Applicant submits an NOI for a new project on or after 12/8/24.	Submit 2024 NOI.	Take action under 2024 PAG-02.
Existing permittee's PAG-02 coverage expires between 8/31/24 and 12/7/24 and they are ineligible for the 2024 PAG-02 or opt to apply for an Individual Permit.	Submit Individual Permit application by permit expiration date. <sup>5</sup>	Collect fees for an Individual Permit renewal. Conduct review based on whether the application includes proposed or necessary project changes.

- Assumes NOI can be approved. Permittees are considered to have continued PAG-02 coverage until issuance as long as the NOI was submitted by 12/7/24. If approved prior to 12/8/24 then the PAG-02 authorization letter will notify the permittee that the CCD is both approving renewed or amended coverage under the 2019 PAG-02 as well as continued coverage under the 2024 PAG-02 through one action.
- 2 The NOI associated with the 2019 PAG-02 General Permit.
- 3 The permittee can continue to use the 2019 NOI (and modules) for amendments to illustrate what has changed even after 12/7/24 or they may opt to use the 2024 NOI (and modules) for this purpose.
- 4 An Administrative Filing Fee of \$500 is required for both Major Amendment and Minor Amendment NOIs that are submitted between 8/31/24 and 12/7/24. The \$500 fee for Minor Amendment NOIs is for renewal of coverage.
- If the CCD rather than the applicant discovers the project is no longer eligible for PAG-02, the Individual Permit application must be received within 90 days of written notification from the CCD to apply for an Individual Permit.
