The Directors Award is presented to water systems who have completed a successful review in the Partnership's Self-Assessment and Peer Review phase, a phase in which utilities examine the capabilities of their treatment plant operation and administration and then create a plan for implementing improvements. This year, 19 of PAWC's filter plants are being recognized with a national award for maintaining active Phase III (Directors Award) status for 5 years. This is a significant accomplishment as it demonstrates ongoing commitment to optimizing filter plant performance.

■ PfSW Tips:

✓ If you are using DEP's Dweller to submit turbidity results electronically you can easily copy and paste to the PfSW turbidity program. Make sure that when you paste the turbidity results, you use paste special and choose values only. You do not want to copy the various colors (ie. Green, yellow, etc)

■ Tips for using the Performance Potential Disk

- ✓ If you are having trouble with the bottom three boxes (ok,, cancel,help) showing up on each/some screens then change your pixels. The computers from DEP were set at 640 x 480. If you change them to 800 x 600 you should not have a problem.
- ✓ If you have more than 12 filters you will need to fill out the filtration section twice, putting half of your filters in once and the other half in the second time.

Plants Going for Phase IV — CONTACT AWWA FIRST!

All plants that are actively pursuing the requirements of Phase IV to achieve the "Excellence in Water Treatment Award" should contact Bill Lauer or Debby Qualls at AWWA before they get too far in the process. The Partnership will assign a "Facilitator" at NO charge to work with the plant during the preparations for the Phase IV application. The Facilitator is one of the PEAC vice-chairs who will be able to answer questions about the process. Facilitated Phase IV applications have gone through the process with a minimum of delay. Take advantage of this assistance.
