Working through the Phase III self-assessment results in the identification of limiting factors and the development of action plans to improve performance. Partnership utilities consistently report significant performance improvement without major capital expenditures. The "Self Assessment" takes time and effort, but taken in increments it can be done systematically over a period of time. As operators we evaluate the plant's overall performance everyday. By focusing your evaluation one process at a time with stated goals in mind, you can make progress towards completing the assessment and improving your operation at the same time.

WTP's that have completed Phase II should proceed to the completion of Phase III of the PfSW program because of the unique opportunity to get a relatively large group together (operators, maintenance personnel, management) to brainstorm different ideas, to discuss their feasibility and implementation. The ultimate advantage is to reduce the finished water turbidity level and maintain it there on a consistent basis and, speaking from the bottom line, reduce over-all operating costs.
