4. FIRST AID MEASURES

Eye Contact: Immediately flush with clean, cool water for 15 minutes and if irritation persists, get medical attention.

Skin Contact: Immediately wash skin with soap and plenty of water while removing contaminated clothing, for at least 15 minutes. If irritation persists, get medical attention. Launder contaminated clothing before reuse.

Inhalation: Remove victim to fresh air. If individual experiences nausea, headache, dizziness, has difficulty in breathing or is cyanotic, seek medical attention. If not breathing, give artificial respiration via a suitable mechanical device such as a bag and mask. Do not use mouth-to-mouth resuscitation.

Ingestion: Do not induce vomiting. Rinse mouth with copious quantities of water first and get immediate medical attention. Drink several glasses of water. Never give anything by mouth to an unconscious person. If vomiting occurs, keep airways clear.

5. FIRE FIGHTING MEASURES

Specific Hazards Arising from the Chemical: Product may be irritating to the eyes, skin, and respiratory system. Closed containers may rupture (due to buildup of pressure) when exposed to

extreme heat. If evaporated to dryness, some product residuals may burn. Thermal decomposition may release oxides of carbon.
