SECTION 4: FIRST AID MEASURES

4.1. Description of First-aid Measures

5.1. Extinguishing Media

6.2. Environmental Precautions

Prevent entry into waterways, sewer, basements or confined areas. Avoid discharge to the aquatic environment. Contact local authorities in case of spillage to drain/aquatic environment. 8.2. Exposure Controls

Appropriate Engineering Controls: Adequate ventilation should be provided whenever the material is heated or mists are
