Summary of Review

The applicant requests a renewal of their NPDES permit to discharge stormwater from DSM Biomedical, Inc. This facility is located at 735 Pennsylvania Drive, Exton, PA 19341. The facility contains two outfalls that discharges stormwater to Shamona Creek in watershed – 3H, a designated High Quality – Trout Stocking Fishes (HQ – TSF) under Chapter 93.

This facility contains two outfalls (001 & 002). Outfall 001 receives stormwater from 499,711 ft² of drainage area from 64% impervious parking lot with no industrial activities. Potential areas of concern for Outfall 001 is fuel oil storage and isopropyl alcohol bulk storage. Outfall 002 receives stormwater from 173,068 ft² of drainage area from 50% impervious of t he parking lot

The applicable appendix for this facility per SIC code 3841 is PAG-03 is Appendix J for Additional Facilities. The existing stormwater parameters Oil and Grease, pH and TSS are continued semiannually in the draft permit. These are in consistent with the Industrial Waste Stormwater module, Appendix J.

Since the facility discharges to High Quality (HQ) or Exceptional Value (EV) waters, it is not eligible for coverage under the PAG-03 General Permit and are not eligible for No Exposure Certification approval.

According to the past inspection reports (12/17/2021) the overall conditions at the facility were good.

Benchmark values for TSS (100 mg/l) and Oil and Grease (30 mg/l) are also included in part C of the permit. This is based on PAG03 General Permit for Discharges of Stormwater associated with industrial activity. pH limit was added in the initial permit and will remain for this renewal.

Summary of Review

There were no other changes to the facility, wastewater quantities, qualities and receiving stream designation since last permit renewal, therefore, previously established effluent limits and monitoring requirements will remain for this current renewal.

Public Participation

DEP will publish notice of the receipt of the NPDES permit application and a tentative decision to issue the individual NPDES permit in the *Pennsylvania Bulletin* in accordance with 25 Pa. Code § 92a.82. Upon publication in the *Pennsylvania Bulletin*, DEP will accept written comments from interested persons for a 30-day period (which may be extended for one additional 15-day period at DEP's discretion), which will be considered in making a final decision on the application. Any person may request or petition for a public hearing with respect to the application. A public hearing may be held if DEP determines that there is significant public interest in holding a hearing. If a hearing is held, notice of the hearing will be published in the *Pennsylvania Bulletin* at least 30 days prior to the hearing and in at least one newspaper of general circulation within the geographical area of the discharge.
