Internal Review and Recommendations

Renewal of NPDES MS4 permit.

The applicant is requesting renewal of their NPDES MS4 permit to discharge stormwater to Mill Creek, Collins Creek and Tributary 28393 to Spring Brook. Mill Creek and Collins Creek are both designated as CWF/MF receiving streams in state water plan basin 05-A (Lackawanna River). Tributary 28393 to Spring Brook is designated as a HQ-CWF/MF receiving stream in state water plan basin 05-A. As per the Department's current existing use list, the receiving streams do not have existing use classifications that are more protective than their designated uses. The permittee was previously covered under a general MS4 permit (PAG132246). There were no outfalls identified on Tributary 28393 to Spring Brook in the permit renewal application. A site visit conducted on December 11, 2019 by the permit engineer confirmed the presence of at least one point source discharge on the HQ stream segment.

A Pollutant Reduction Plan (PRP) was required to be submitted with the permit renewal application since the Susquehanna River and Lackawanna River are both impaired for siltation within a 5-mile buffer of the urbanized area in Pittston Township, and also because stormwater generated in the urbanized area within the municipality discharges in the Chesapeake Bay watershed. The permittee was required to develop and submit a Pollutant Reduction Plan (PRP) with the permit application describing how 10% of their existing sediment loading to the receiving streams will be removed within five years of the permit effective date (see Appendices D and E of the permit). Pittston Township entered into an agreement with Wyoming Valley Sanitary Authority (WVSA) to be included in the Wyoming Valley Regional Stormwater Management Program. A joint PRP was submitted to DEP by WVSA and covers all municipalities that entered into the agreement. The permittee shall also implement Pollutant Control Measures (PCMs) within the storm sewershed of any outfall that discharges to waters impaired for metals and polychlorinated biphenyls (PCBs) as described in Appendices A and C of the permit.

The previously issued permit expired on March 15, 2018 and the application for permit renewal was submitted on time. There are no open violations for this client that would warrant withholding the issuance of the final permit.

Internal Review and Recommendations

Any person may request or petition for a public hearing with respect to the application. A public hearing may be held if DEP determines that there is significant public interest in holding a hearing. If a hearing is held, notice of the hearing will be published in the *Pennsylvania Bulletin* at least 30 days prior to the hearing and in at least one newspaper of general circulation within the geographical area of the discharge.
