Internal Review and Recommendations

Per 40 CFR § 122.33, and PA Title 25 § 92a.3, Centre Township (the applicant) is required to seek coverage under an NPDES permit issued by the state of Pennsylvania. The applicant originally submitted a Notice of Intent for coverage under a PAG-13 under PAG133667. The PAG-13 General Permit was administratively extended from 3/15/2023 through 3/15/2025. New PAG-13 coverage cannot be authorized while the General Permit is administratively extended. Since an approvable Pollutant Reduction Plan was not received prior to 3/15/2023, the applicant was required to submit an application for coverage under an individual MS4 NPDES permit. Per PA Title 25 § 92a.54, the applicant is eligible for permit coverage. PAG133667 will be withdrawn upon issuance of PAI133552.

The applicant discharges to the following waters: Schuylkill River (WWF, MF), Irish Creek (WWF, MF), Plum Creek (WWF, MF).

According to the MS4 Requirements Table, the applicant is subject to the following IP appendix requirements:

Public Participation

DEP will publish notice of the receipt of the NPDES permit application and a tentative decision to issue the individual NPDES permit in the *Pennsylvania Bulletin* in accordance with 25 Pa. Code § 92a.82. Upon publication in the *Pennsylvania Bulletin*, DEP will accept written comments from interested persons for a 30-day period (which may be extended for one additional 15-day period at DEP's discretion), which will be considered in making a final decision on the application. Any person may request or petition for a public hearing with respect to the application. A public hearing may be held if DEP determines that there is significant public interest in holding a hearing. If a hearing is held, notice of the hearing will be published in the *Pennsylvania Bulletin* at least 30 days prior to the hearing and in at least one newspaper of general circulation within the geographical area of the discharge.
