**Summary of Review**

The applicant is requesting renewal of an NPDES permit to discharge stormwater associated with an industrial activity to Monocacy Creek (HQ-CWF, Stream code: 3384), a high-quality, cold-water fishery, migratory fishery-designated receiving stream (HQ-CWF, MF) in State Water Plan Basin 02-C. The receiving body does not have an existing use classification.

This facility is an existing Hot Mix Asphalt plant located within 50 feet of the Monocacy Creek, with an estimated ~240,887 square feet area. Stormwater flow from two drainage area represented by two Outfalls as sheet flow only. Outfall (001) drains the east side of the facility at Allen Township side and discharges directly to Monocacy Creek.


Outfall (002) drains the western side then discharges to a berm just before Monocacy Creek. Based on previous applications, the berm is constructed as structural BMP to control the pollutants. Most water infiltrates and evaporates as it drains towards the berm.

The oil and asphalt production tanks are kept in secondary containment separated from the stormwater flow.

The facility is categorized by SIC code 2951 (Asphalt manufacturing industry) and falls under **Appendix M** monitoring requirements of the new PAG-03 General Permit. Semiannual monitoring /reporting includes Total Suspended Solids (TSS), Oil & Grease, pH, Total Nitrogen, Total Phosphorus. Benchmarks exist for TSS, Oil & Grease and pH.

Benchmark values are not effluent limitations, and exceedances do not constitute permit violations. However, if the permittee's sampling demonstrates exceedances of benchmark values for two or more consecutive monitoring periods, the permittee shall take action in accordance with Part C. III. F. of the permit.

A corrective action plan (CAP) must be submitted to DEP if the discharge concentration for the parameters exceeds the benchmark values for two or more consecutive monitoring periods.

### Summary of Review

Permittee has been reporting results in many sampling periods of 2024 as NODI code E or FF. This reporting is considered by the Department as a violation of your permit. Permittee is reminded not to use these reporting codes.

A routine RTPT inspection was performed by the department staff on October 13, 2023 and no violations were reported.

WMS Query by client report was run and returned no violations.

### Public Participation

DEP will publish notice of the receipt of the NPDES permit application and a tentative decision to issue the individual NPDES permit in the *Pennsylvania Bulletin* in accordance with 25 Pa. Code § 92a.82. Upon publication in the *Pennsylvania Bulletin*, DEP will accept written comments from interested persons for a 30-day period (which may be extended for one additional 15-day period at DEP's discretion), which will be considered in making a final decision on the application. Any person may request or petition for a public hearing with respect to the application. A public hearing may be held if DEP determines that there is significant public interest in holding a hearing. If a hearing is held, notice of the hearing will be published in the *Pennsylvania Bulletin* at least 30 days prior to the hearing and in at least one newspaper of general circulation within the geographical area of the discharge.
