**From Philadelphia and Southwestern Pennsylvania:**

Take I-476 North to exit #105 (Wilkes-Barre) to PA-115 North (Bear Creek Boulevard). Continue on PA-309 North (PA-115 turns into PA-309 at I-81). Take exit #1 to PA-315 North and turn left at the signal light (Kidder Street). At the second signal light, turn right into the Woodlands Inn parking lot.
