

Planned DC Fast Charging and Hydrogen Fueling Stations

For a project to be classified as Corridor Expansion and receive the benefits described in the Program Guidelines, it must be located within 3 miles of an interstate highway interchange and be located within a charging/fueling station gap of greater than 50 miles along that interstate. Both existing and planned stations must be considered when determining if there is a charging/fueling gap of greater than 50 miles. The following is a list of known planned DC fast charging station installations in Pennsylvania. (DEP is not aware of any planned hydrogen fueling stations.) For convenience, they are organized by major MSA (defined in Section III. G. of the Program Guidelines).
