Radon Basics:

- Radioactive Gas
- Naturally Occurring
- Can't see, smell, or taste



Radon Health Information and Risks:

- Class A carcinogen
- Lung Cancer only known health effect



EPA Risk Estimates, June 2003 Males and Females

	Lung Cancer Deaths	Radon Attributable
Total	157,400	21,800
Smokers	146,400	18,900
Non-smokers	11,000	2,900

Pennsylvania Specifics:

- About 1.5 million test results
- Likely the most severely affected state in the U.S.
- Average basement reading of 7 pCi/L, first floor 3.5 pCi/L
- About 40% of readings greater than EPA guideline



Previous targeted surveys

- 14 surveys from the following counties:
- Lehigh, Berks, York, Clearfield, Lancaster,
 Montgomery, Chester, Lackawanna, Potter,
 Luzerne, and Dauphin
- These surveys are used to increase awareness in higher risk areas.



Upper Saucon Twp Survey

Letters sent	505	
Tests supplied	283	56%
Tests analyzed (to date)	145	29%

Our goal is for 100% response

Upper Saucon Twp Survey

	Count	Percentage
0 - 4 pCi/L	66	45.5 %
4 - 20 pCi/L	45	31.0 %
20 - 100 pCi/L	17	11.7 %
100 - 999 pCi/L	10	6.9 %
> 1,000 pCi/L	7	4.8 %

55% of these results are over 4 pCi/L. Typically, only 40% of results in PA are over 4 pCi/L
