This municipal notice, under the requirements of Acts 14, 67, 68, and 127 of the Municipalities Planning Code, is to inform you of our intent to submit the subject permit applications to the Pennsylvania Department of Environmental Protection (DEP) for the following proposed project:

Project Name: Tioga Pathway Project (Project)

Applicant Name: National Fuel Gas Supply Corporation (National Fuel)

Project Description: National Fuel is proposing to construct and operate the Project and to abandon certain pipeline facilities. The Project is located in Potter, Tioga, and McKean counties, Pennsylvania (PA), and consists of the construction and operation of the following facilities described in more detail as follows:

- **Z20 Replacement Pipeline:** Replace approximately 3.84 miles of 12-inch 1936-vintage bare steel pipeline with new 20-inch coated steel pipeline in National Fuel's existing right-of-way (ROW) in Potter County;
- **YM59 Mainline Pipeline:** Install approximately 19.48 miles of new 20-inch coated steel pipeline beginning at the east end of the 3.84-mile Z20 Pipeline replacement, traversing Potter, and Tioga counties, and ending at the NFG Midstream Covington, LLC (Midstream) Lee Hill Interconnect;

- Auxiliary Facilities:
 - McCutcheon Hill Over-pressure Protection (OPP) Station: Construct a new OPP station at the interconnection between the eastern terminus of the Z20 Replacement Pipeline and the western terminus of the YM59 Mainline Pipeline in Potter County;
 - Measurement equipment at Midstream's Lee Hill Interconnect: Install gas measurement, gas quality, flow control, OPP devices, a pig launcher, and associated appurtenances (Measurement Facilities) at Midstream's Lee Hill Interconnect to connect the proposed YM59 Mainline Pipeline to Midstream's facilities at the east end of the Project in Chatham Township, Tioga County;
 - Perform minor modifications at National Fuel's existing Ellisburg Compressor Station (CS) including replacing/installing measurement, OPP devices, flow control, and other associated appurtenances in Potter County;
 - Construct one new remote-control valve (RCV) setting at a location along the YM59 Pipeline in Tioga County;
 - Perform modifications to an existing valve setting on the Z20 Replacement Pipeline in Potter County; and
 - Install a new cathodic protection ground bed at a location along the YM59 Pipeline in Tioga County.¹

To support construction activities and operation of the Project, National Fuel estimates that approximately 3.96 miles of temporary access roads (TARs) and 1.76 miles of permanent access roads (PARs) will be used. In addition, three (3) previously used staging areas (Port Allegany Pipe Yard, Harrison Valley Contractor Yard [HV Contractor Yard], and Middlebury Contractor Yard) will be used to store materials and equipment.

Site Location: The location of the proposed Project is shown on the attached United States (U.S.) Geological Survey (USGS) Project Location Map(s).

Municipality/County: The Project is located in the following municipalities and counties:

- Allegany and Harrison Townships, Potter County;
- Brookfield, Westfield, Deerfield, Chatham, and Middlebury Townships, Tioga County; and
- Liberty Township, McKean County.

Section 1905-A of the Commonwealth Administrative Code, as amended by Act 14, requires that each applicant for a DEP permit must give written notice to the municipality(ies) and the county(ies) in which the permitted activity is located. The written notice shall be received by the municipality(ies) and county(ies) at least 30 days before the DEP may issue or deny the permit.

Acts 67 and 68, which amended the Municipalities Planning Code to support sound land use practices and planning efforts, direct state agencies to consider comprehensive plans and zoning ordinances when reviewing applications for permitting of facilities or infrastructure and specify

that state agencies may rely upon comprehensive plans and zoning ordinances under certain conditions as described in Sections 619.2 and 1105 of the Municipal Planning Code. A Chapter 102 Municipal Notification Form and Chapter 105 General Information Form (GIF) for the Project are attached for your reference.

DEP invites you to review the attached information and comment on the land use aspects of this Project; please be specific to DEP when identifying any areas of conflict. If you wish to submit comments for DEP to consider in a land use review of this Project, you must respond within 30 days to the DEP office listed below. If there are no land use comments received by the end of the comment period, DEP will assume that there are no substantive land use conflicts and proceed with the normal application review process.

- Linear pipeline, multiple properties in Potter and Tioga counties, and pipe yard in McKean County, PA. Approximately 3.84 miles of National Fuel's existing 12-inch-diameter vintage bare steel Z20 Pipeline will be replaced with new 20-inch diameter pipeline in National Fuel's existing 50-foot-wide pipeline ROW in Potter County. The Project also includes approximately 19.48 miles of new 20-inch-diameter steel YM59 Pipeline starting in Harrison Township in Potter County, and will continue east for approximately 2.89 miles before crossing into Tioga County. In Tioga County, the pipeline will traverse the townships of Brookfield, Westfield, Deerfield, and Chatham. Land use types along the Z20 Pipeline consist of agricultural land, forest/woodland, open land, and residential land. Land use types along the YM59 Pipeline consist of agricultural land, forest/woodland, open land, scrub/shrub, developed land, and residential land. 



Project Description: National Fuel is proposing to construct and operate the Project and to abandon certain pipeline facilities. The Project is located in Potter, Tioga, and McKean counties, Pennsylvania (PA), and consists of the construction and operation of the following facilities described in more detail as follows:

- **Z20 Replacement Pipeline:** Replace approximately 3.84 miles of 12-inch 1936-vintage bare steel pipeline with new 20-inch coated steel pipeline in National Fuel's existing right-of-way (ROW) in Potter County;
- **YM59 Mainline Pipeline:** Install approximately 19.48 miles of new 20-inch coated steel pipeline beginning at the east end of the 3.84-mile Z20 Pipeline replacement, traversing Potter and Tioga counties, and ending at the NFG Midstream Covington, LLC (Midstream) Lee Hill Interconnect;

- Auxiliary Facilities:
 - McCutcheon Hill Over-pressure Protection (OPP) Station: Construct a new OPP station at the interconnection between the eastern terminus of the Z20 Replacement Pipeline and the western terminus of the YM59 Mainline Pipeline in Potter County;
 - Measurement equipment at Midstream's Lee Hill Interconnect: Install gas measurement, gas quality, flow control, OPP devices, a pig launcher, and associated appurtenances (Measurement Facilities) at Midstream's Lee Hill Interconnect to connect the proposed YM59 Mainline Pipeline to Midstream's facilities at the east end of the Project in Chatham Township, Tioga County;
 - Perform minor modifications at National Fuel's existing Ellisburg Compressor Station (CS) including replacing/installing measurement, OPP devices, flow control, and other associated appurtenances in Potter County;


