Preface

This addendum to the 2017 Class A Wild Trout Streams Report consists of stream maps for all of the streams or stream segments that are being considered for redesignation to HQ-CWF along with the Class A Stream Redesignation Rulemaking Package. All of these recommended revisions which are included in the Class A Stream Redesignation Rulemaking are the result of stream evaluations conducted by the Department in response to data submitted from the Pennsylvania Fish and Boat Commission (PFBC) under §93.4c (relating to implementation of antidegradation requirements). Section 93.4c(a)(1) pertains to the process for changing a designated use of a stream. In this rulemaking, redesignations rely on §93.4b(a)(2)(ii) (relating to qualifying as High Quality or Exceptional Value Waters) to qualify streams for High Quality (HQ) designations based upon their classifications as Class A wild trout streams. A surface water that has been classified a Class A wild trout stream by the PFBC, based on species-specific biomass standards, and following public notice and comment, and approval by the PFBC Commissioners, qualifies for HQ designation. The PFBC published notice and requested comments on the Class A designation of these streams. The Commissioners of the PFBC approved these waters after providing public notice and review of the comments received.

The regulation was adopted by the EQB as proposed rulemaking at its December 18, 2018 meeting, and was published in the *Pennsylvania Bulletin* on March 23, 2019 (49 Pa.B. 1367) with provision for a 45-day public comment period that ended May 7, 2019. The EQB held one public hearing, for the purpose of accepting comments on the proposed rulemaking, on April 26, 2019 at the Department's Southcentral Regional Office in Harrisburg, Pennsylvania.


The Department received comments which prompted reconsideration for some of the recommendations included in the proposed rulemaking. The Department changed its recommendations to expand the zones to be redesignated to HQ-CWF in seven of the streams based on the submission and discussion of additional data and information that supported this change. There are 13 more stream miles, in total, being recommended for redesignation in this final rulemaking than were included in the proposed rulemaking. The following table (Table 1) provides a summary of the changes made to

the recommendations after the Department's reconsiderations between the proposed and final rulemaking.


Proposed HQ-CWF Stream Basins









UNT 03913 to Lehigh River (Nis Hollow) Creek - Carbon County





UNT Little Schuylkill River - Schuylkill County



UNT Little Schuylkill River (Rabbit Run) - Schuylkill County









Brace Brook - Susquehanna/Wayne County



Emeigh Run - Cambria County





Patchin Run - Clearfield County





UNT 27365 to West Branch Susquehanna River - Clearfield County



Hogback Run - Clearfield County









Gap Run - Centre County





Salt Lick Run - Centre County





Rauchtown Creek - Lycoming/Clinton County



Mosquito Creek - Lycoming County



Potter Run - Centre County



Kettle Run - Centre County




















