- 1. Approval of the December 16, 2015, Minutes No corrections were suggested. Ms. Shuler motioned to approve the December 16, 2015, Meeting Minutes. Mr. Sheetz seconded the motion. The vote was unanimous; motion carried.
- Certification of new Sewage Enforcement Officers (SEO's) Ms. Szwajkowski had previously distributed the names and scores of the 2 candidates who took the March 7, 2016, SEO exam. Neither candidate passed the examination and therefore, do not meet Department of Environmental Protection (Department) regulations in order to become certified as SEO's. No vote is necessary.
- New Business The Local Government Representative for the Board Alan Everett has passed away since the December 16, 2015, meeting. Also, a Sewage Advisory Committee (SAC) Representative for the Board – Ms. Alison Shuler – has declined appointment for another 4 year term serving the Board. Ms. Shuler's term will expire April 17, 2016. The

Board and Department are thankful for both Mr. Everett's and Ms. Shuler's service to the Board.

The Board again expressed a concern with both the lack of Soils training provided to candidates in the SEO Pre-Certification Academy currently offered by the Pennsylvania State Association of Township Supervisors and the lack of Soils continuing education courses available to certified SEO's.

Mr. Diehl notified the Board that the Department released an email or letter in January 2016 to all "Active" and "Lapsed" SEO's which reminded SEO's of the upcoming certification renewal period and also detailed updated and new policies. He also stated that a copy of the letter can be found on the Department's webpage for SEO's.
