Enclosed please find a minor modification to Solid Waste Permit No. 101719 for the construction and operation of the Camp Hope Run Landfill. This permit is issued in accordance with Article V of the Solid Waste Management Act, 35 P.S. Section 6018.101, et seq.

This modification approves the inclusion of a condition addressing the following:

- Right-of-Way granted in Camp Rattlesnake's Deed dated December 27, 1995, (Vol. 1727 Page 219), between Al Hamilton Contracting Company and Camp Rattlesnake.
- Proof that the dispute has been resolved may be by means of a final determination by a court of competent jurisdiction or by agreement between PA Waste and Camp Rattlesnake.

Included with the permit modification is the following revised Appendix;

A revised Appendix E (List of Approved Permit Modifications) and Attachment 1 to Appendix E. Please remove the previously issued Appendix E and replace it with the attached Appendix E. Attach the Form 13-A to Attachment 1 of Appendix E.

Compliance with the term and condition set forth in the permit is mandatory. Please note that issuance of this permit does not eliminate the necessity to comply with all federal, state, or local requirements at the permitted facility. You have the right to file an appeal as to the terms and conditions of this permit.

This authorization does not relieve the applicant from applying for and obtaining any additional permits or approvals from local, state or federal agencies required for this project. Please be advised that if any other permits are required for this project, they must be issued prior to undertaking the activities described in those permit applications. Issuance of the enclosed permit(s) does not indicate an affirmative action on any other pending or future permit applications.

Any person aggrieved by this action may appeal the action to the Environmental Hearing Board (Board) pursuant to Section 4 of the Environmental Hearing Board Act, 35 P.S. § 7514, and the Administrative Agency Law, 2 Pa.C.S. Chapter 5A. The Board's address is:
