

## **Benner Township PFAS Investigation HSCA Site**

The Department of Environmental Protection (DEP), is holding a public hearing to provide residents of Benner Township with information of the prompt interim response, consisting of provision of bottled drinking water, being implemented for this site. DEP will also receive public comments on its proposed prompt interim response action of installation of whole-house filtration systems on private residential water supplies with combined concentrations of PFOS and PFOA exceeding the United States Environmental Protection Agency (EPA) health advisory level (HAL) of 70 parts per trillion (ppt). Prior to the hearing, DEP will give a brief presentation updating our progress to date.

This notice is being provided pursuant to Section 506(b) of HSCA. The Administrative Record, which contains the information that forms the basis and documents the selection of this response action is available for public review and comment. The Administrative Record is available electronically on DEP's project specific website at [www.dep.pa.gov/BennerHSCA](http://www.dep.pa.gov/BennerHSCA). The Administrative Record will be open for comment from May 28, 2022 until August 26, 2022.
