**Subject: Municipal Notification – NPDES/Chapter 105 General Permit Registration  
Homer City Generation LP – Power Plant Road Relocation Project  
Black Lick and Center Townships, Indiana County, Pennsylvania**

This municipal notice is to inform you that Homer City Generation LP (Homer City) is applying for coverage under the NPDES General Permit Application for Discharges of Stormwater Associated with Construction Activities under 25 PA Code Chapter 102. Additionally, Homer City will be registering for Chapter 105 General Permit GP-7 (Minor Road Crossings) and GP-8 (Temporary Road Crossings) for associated construction activities.

Act 14 of the Commonwealth Administration Code requires that each applicant for a DEP permit give written notice to the municipality and the county in which the permitted activity is located. As amended by Acts 67, 68 and 127 of 2000, the Municipalities Planning Code directs state agencies to consider comprehensive plans and zoning ordinances when reviewing applications for permitting of facilities or infrastructure and specifies that state agencies may rely upon comprehensive plans and zoning ordinances under certain conditions as described in Sections 619.2 and 1105.

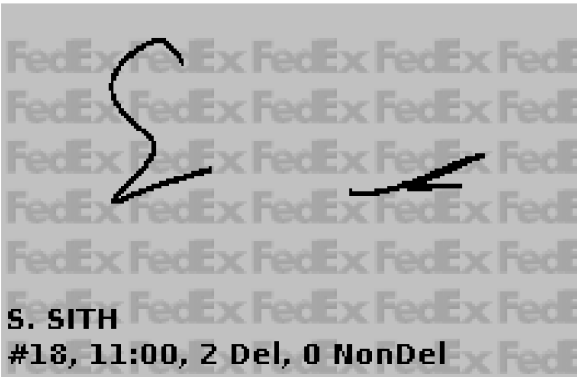
