A 20-inch diameter pipeline would be installed within the ROW from Houston to Marcus Hook (306 miles) and a second, up to 20-inch diameter pipeline, would also be installed in the same ROW from SPLP's Delmont Station in Westmoreland County to the Marcus Hook facility (for approximately 255 miles). Approximately 33.1 miles are located in Cumberland County. No compressor station upgrades/modifications are proposed in Cumberland County.
