As discussed earlier today with Allison Hill of your office, we understand that Adelphia Gateway is requesting to increase their earth disturbance activities from 1.3 acres as initially submitted for the above referenced application to 24.76 acres. At this time, we are requesting the following items to continue our coordinated technical review of this phase.

- 1. Conservation District fee of \$925.00
- 2. DEP disturbed acre fee of \$2,400.00
- 3. Amended E&S/Site Restoration Plan drawings

For Item 1, the applicant should send the Conservation District fee to the Delaware County Conservation District (DCCD), 1521 N Providence Rd, Media, PA 19063 (ATTN: Ed Magargee). Please contact Mr. Magargee if you have any questions regarding this item.

For Item 2, the applicant should send the DEP disturbed acre fee to the DEP Southeast Regional Office, 2 East Main Street, Norristown, PA 19401 (ATTN: Aaron Redmond). (\$100/Acre of earth disturbance payable to the "Commonwealth of PA Clean Water Fund") Also, please update the DEP NOI Checklist and DEP NOI for this requested increase in earth disturbance.

For Item 3, the applicant should amend the E&S/Site Restoration plan drawings to identify/label and delineate the proposed temporary parking, material laydown areas, and stockpiling areas. Please add adequate erosion and sedimentation (E&S) BMPs for these temporary earth disturbance activities. Also, please verify that the sequence of construction includes the install, operation/maintenance, and removal of these temporary earth disturbance activities and the associated E&S BMPs. In addition, please verify that the construction details and specifications for these areas and associated BMPs have been added to the plan drawing set. Please verify that the Site Restoration BMPs for these earth disturbance areas have been added to the E&S/Site Restoration plan drawings.
