Under the authority of Pennsylvania's Clean Streams Law, the Department of Environmental Protection (DEP) has approved your request for amendment of coverage under the Erosion and Sediment Control Permit (E&S Permit) for the PA Pipeline Project/Mariner East 2 project. The latest versions of the Notice of Intent (NOI) and all supporting documents, including the Erosion and Sediment Control (E&S) Plan and Post-Construction Stormwater Management (PCSM) Plan, are incorporated into this approval, including the following plan drawings:

- The Erosion and Sediment Control & Site Restoration Plan drawings, for the Pennsylvania Pipeline Project, Construction Spread 6, dated February 6, 2017, and last revised June 25, 2021.

Your coverage under the E&S Permit, which will continue through Permit No. ESG0100015001, is effective on December 1, 2021, and will expire on February 12, 2022. It is acknowledged that your permit renewal request for E&S Permit No. ESG0100015001 has been received and is under review.

Any person aggrieved by this action may appeal the action to the Environmental Hearing Board (Board), pursuant to Section 4 of the Environmental Hearing Board Act, 35 P.S. § 7514, and the Administrative Agency Law, 2 Pa.C.S. Chapter 5A. The Board's address is:

Appeals must be filed with the Board within 30 days of receipt of notice of this action unless the appropriate statute provides a different time. This paragraph does not, in and of itself, create any right of appeal beyond that permitted by applicable statutes and decisional law.


