Dear Mr. Bryan:

We received your team's resubmission on June 1, 2021 based on the May 26, 2021 technical deficiency letter. The Department of Environmental Protection (DEP) and the Chester County Conservation District (District) have reviewed your team's resubmission for the above referenced application and has identified the technical deficiencies listed below. The *Pennsylvania Erosion and Sediment Pollution Control Program Manual* (E&S Manual) and the *Pennsylvania Stormwater Best Management Practices Manual* (BMP Manual) include information that may aid you in responding to some of the deficiencies listed below. The deficiencies are based on applicable laws and regulations, and the guidance sets forth DEP's established means of satisfying the applicable regulatory and statutory requirements.

Technical Deficiencies

1. Please utilize a minimum of 24" Filter Sock adjacent to streams and wetlands. See adjacent to wetland H60, WL H17, etc. Check entire Major Mod plan and revise as needed. 102.4(C)

E&S Comment 1 not addressed. Please provide 24" filter sock along wetlands, see WL H60 on sheet ES-6.28. 102.4(c)

2. Perimeter Filter sock BMPs should be designed for the maximum slope tributary to them, not just the LOD, please revise plans accordingly. 102.11(a)(1)

No further information required at this time.

3. Please clearly illustrate the stream crossing including the method of stream diversion on the plan mapping and provide a blow up of the stream crossing bypass system. 102.11(a)(1)

No further information required at this time.

4. Please provide E&S Controls along the LOD adjacent to the existing house and driveway at station 14806+00. 102.11(a)(1)

No further information required at this time.

5. There is off road LOD shown on the North East corner of the intersection of Milford and Little Conestoga Road, please provide E&S controls at this location. 102.11(a)(1)

No further information required at this time.

6. Please provide clearance letters from each of the PNDI agencies and the PHMC for the above referenced ESCGP-3 permit application. If your team receives recommendations from any of the PNDI agencies and/or the PHMC in the form of conservation measures, avoidance measures, etc., please provide a demonstration for how your team will be addressing the recommendations with any cross references to the plan drawings.

This comment was not addressed. Please address the comment in its entirety and provide the clearance letters in one resubmission to address the comment. Your team's response letter indicates that clearance letters were provided under separate cover for most of the PNDI agencies and the PHMC. However, these clearance letters were provided in piecemeal submissions and under the e-mail heading of Chapter 105.

You must submit a response fully addressing each of the technical deficiencies set forth above. Please note that this information must be received within 30 calendar days from the date of this letter, or the DEP may deny the ESCGP-3 Permit application.

Please submit a response letter addressing the above comments and 1 electronic copy of the revised information to the District and DEP.

Please coordinate with the District prior to resubmitting. The District may require a District application and/or additional fees associated with your resubmission.

If you believe that any of the stated deficiencies are not significant, instead of submitting a response to that deficiency, you have the option of requesting that DEP make a permit decision based on the information you have already provided regarding the subject matter of that deficiency. If you choose this option with regard to any deficiency, you should explain and justify how your current submission satisfies that deficiency.
