Dear Mr. Mitchell:

This letter is in response to the May 22 letters sent to DEP by your consultant, Compliance Plus Services. The three letters state that R.E. Pierson either has not constructed or no longer requires the permits associated with the hot mix asphalt plant and associated engines, portable non-metallic mineral processing plant and associated engines, and the 1,000 ton/hour non-metallic mineral processing plant. A description of these authorizations and the equipment they covered is attached to this letter. DEP acknowledges the requests to allow the plan approval to expire and that R.E. Pierson no longer needs the general permits at this location.

As requested, the authorization for the general permits are no longer required. For the portable crushing plant and associated engines, these sources are being used at another location under another authorization, thereby making the authorization for the Rock Hill Quarry no longer valid. For the asphalt plant and associated engines, the sources were never constructed. These authorizations are considered inactive and no longer valid for the Rock Hill Quarry. The Plan Approval Authorization #09-0241 expired on its own terms on May 30, 2020.
