The Department of Environmental Protection (Department) hereby issues, in accordance with Article V of the Solid Waste Management Act, 35 P.S. Sections 6018.101, *et seq.*, a minor modification of Solid Waste Permit I.D. No. 100277 authorizing the modification of the groundwater monitoring network to include monitoring well PZ-6A. This modifies Condition No. 17 (A, B, and C) of the major modification of Solid Waste Permit I.D. No. 100277 that became effective on July 30, 2004. The need for this permit modification was a result of the Third Party Environmental Audit required by Corrective Action No. 8 of the November 1, 2023, consent order and agreement between the Department and Westmoreland Sanitary Landfill, LLC.

Compliance with the terms and conditions set forth in Solid Waste Permit I.D. No. 100277 is mandatory. You have the right to file an appeal as to the modified terms and conditions.

This authorization does not relieve Westmoreland Sanitary Landfill, LLC, from applying for and obtaining any additional permits or approvals from local, state, or federal agencies required for this project. Please be advised that if any other permits are required for this project, they must be issued prior to undertaking the activities described in the permit application. Issuance of the attached permit(s) does not indicate an affirmative action on any other pending or future permit applications.

If you are uncertain as to whether or not other permits are needed for this project, please use the Department's *Pre-Application Consultation Tool* (PACT), which can be found at https://www.ahs.dep.pa.gov/PACT/. The online tool is designed to quickly and easily assist potential applicants in determining which types of environmental permits, authorizations, or notifications would be needed for specific projects. Based on the user's responses to a series of

simple questions, PACT automatically provides an email response with information on permits and other information an applicant should consider.

Any person aggrieved by this action may appeal the action to the Environmental Hearing Board (Board) pursuant to Section 4 of the Environmental Hearing Board Act, 35 P.S. § 7514, and the Administrative Agency Law, 2 Pa.C.S. Chapter 5A. The Board's address is:

FORM NO. 13-A MODIFICATION TO SOLID WASTE DISPOSAL AND/OR PROCESSING PERMIT

Under the provisions of Act 97, the Pennsylvania Solid Waste Management Act, the Act of July 7, 1980, P.L. 380, 35 P.S. §§ 6018.101, et seq., Solid Waste Permit I.D. No. 100277 issued on May 24, 1991, to the Municipal Authority of Westmoreland County and reissued to Westmoreland Waste, LLC, on November 13, 1997, to Tervita, LLC, (formerly known as CCS Midstream Services, LLC) on January 19, 2012, and to Westmoreland Sanitary Landfill, LLC, on July 20, 2015, for the operation of the Sanitary Landfill, a Municipal Waste Disposal Site located in Rostraver Township, Westmoreland County, is modified as follows:

1. This permit modifies Solid Waste Permit I.D. No. 100277 originally issued on May 24, 1991. It is issued in response to Solid Waste Permit Application I.D. No. 100277, which was received on January 13, 2025, and designated as Authorization No. 1513310 for permit modification to revise the Water Quality Monitoring Plan to add groundwater monitoring well PZ-6A. Subsequent revisions and addendums submitted to the initial application are approved by the Department of Environmental Protection (Department) and are a part of this permit amendment.

This permit modification is issued based on the assumption that the information submitted in the referenced application and defined in Permit Condition No. 2 is accurate. Any inaccuracies found in this information may be grounds for the revocation or modification of this permit and potential enforcement action.

- 5. Any final operational, design, or other plan developed subsequently to permit issuance which exhibits changes in structure, location, specification, or other changes of substance shall be submitted to the Department for subsequent permit action. Any deviation from the plans herein approved shall not be implemented before first obtaining a permit amendment or written approval from the Department.
