Dear Kimberly Kaal:

The Shell Chemical Appalachia LLC ("Shell") Petrochemicals Complex is authorized to operate pursuant to plan approval PA-04-00740C. The Department of Environmental Protection (DEP) has reviewed stack testing results for various air contamination sources at the facility performed on several dates in 2022 and 2023. The stack test reports show the following violations:

1. PA-04-00740C, Section E, Condition # 005 states that PM10 and PM2.5 emissions from each of the ethane cracking furnaces shall not exceed the following: 3.10 lb/hr under normal operating conditions and 1.86 lb/hr during periods of decoking. The performance tests for particulate matter were evaluated by the Department's Source Testing Section and were determined to be acceptable. The following sources exceeded these PM10 & PM2.5 limits under normal operating mode, as established in the Plan Approval in violation of 25 Pa. Code § 127.12b.

2. PA-04-00740C, Section E, Condition #011 states the "Owner/Operator shall perform VOC, PM10, PM2.5, NH3, and n-Hexane emission testing upon each of the seven ethane cracking furnaces... [i]nitial performance testing is required within 180 days of start-up...." Initial testing was performed within 180 days of start-up for each of the furnaces except Source 037. However, results of some of these tests are unacceptable. Unacceptable test results cannot be used to demonstrate compliance. The initial tests were deemed to be unacceptable for the following sources for specific pollutants indicated below:

By failing to conduct any testing for any parameters within 180 days of start-up for Source 037 and by not conducting compliant testing within 180 days of start-up for the parameters at Sources 031, 033, 034 and 035, as identified in the above table, Shell violated 25 Pa. Code § 127.12b

The above listed violations constitute unlawful conduct and a public nuisance pursuant to Sections 8 and 13 of the Air Pollution Control Act (APCA), 35 P.S. Sections 4008 and 4013, respectively. Violations of DEP's air quality regulations are subject to the penalties of Sections 9 and 9.1 of the APCA. Each day the violation continues constitutes a separate offense.

This Notice of Violation is neither an order nor any other final action of DEP. It neither imposes nor waives any enforcement action available to DEP under any of its statutes. If DEP determines that an enforcement action is appropriate, you will be notified of the action.
