NOTIFICATION LETTER: COMPLETE RMP

The U.S. Environmental Protection Agency (EPA) received your Risk Management Plan (RMP) on the postmarked date listed above. **This letter notifies you that your RMP is "complete" according to EPA's completion check.** The completion check is a program implemented by EPA to determine whether a submitted RMP includes the *minimum* amount of information every RMP must provide. The completion check does not assess whether a submitted RMP should have provided additional information or whether the information contained in the RMP is accurate or appropriate. In other words, the completion check does not indicate that the RMP meets the requirements of 40 CFR Part 68.

Please note the anniversary date indicated above. Your RMP must be updated and submitted on or before the anniversary date, as required by 40 CFR § 68.190. Also note that your EPA Facility Identification Number (EPA Facility ID#) is listed above and at the bottom of the page. All future Risk Management Plan submissions, corrections, and other correspondence must include the EPA Facility ID Number.

We encourage facilities to make all future RMP submissions through RMP*eSubmit. RMP*eSubmit, EPA's software for preparing, updating, and submitting your RMP, is available for your use. The RMP data requirements have not changed, only the method for RMP preparation and submission. RMP*eSubmit is an easy to use, secure Web-based system that improves data quality and allows you to access your RMP online, anytime. RMP*eSubmit imports the data from your facility's latest RMP, making your re-submission easier. Special validation features in the system ensure that the RMP is completed properly, prior to submission. The previous system (RMP*Submit) which required the mailing of diskettes or CDs, was phased out in 2009 and is no longer in use.
