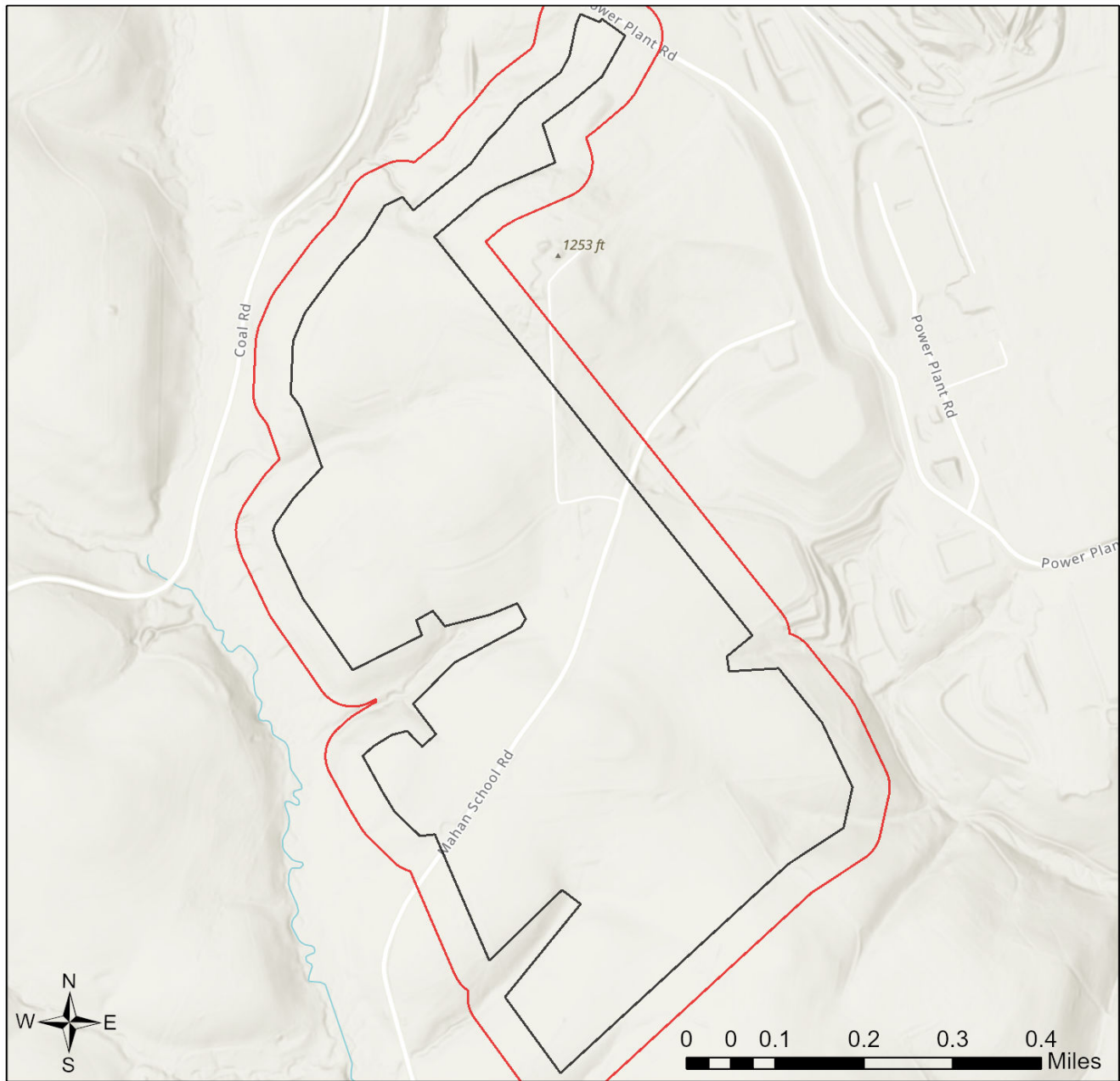




-  Buffered Project Boundary

4. DEP INFORMATION

The PNDI Receipt should also be submitted to the appropriate agency according to directions on the PNDI Receipt.
