Project type, purpose and need: Installation of two parallel natural gas liquid pipelines within an approximately 306-mile, 50-foot-wide right-of-way (ROW) from Houston, Washington County, Pennsylvania to SPLP's Marcus Hook facility in Delaware County, Pennsylvania with the purpose of interconnecting with existing SPLP Mariner East pipelines. A 20-inch diameter pipeline would be installed within the ROW from Houston to Marcus Hook (306 miles) and a second, up to 20-inch diameter pipeline, would be installed in the same ROW from SPLP's Delmont Station in Westmoreland County to the Marcus Hook facility (for approximately 255 miles). Approximately 19.9 miles are located in Washington County. In addition, modifications to an existing pump station are proposed in Washington County. Please refer to Attachment 9 for a detailed project description.
