- A. A detailed description of how baseline and threshold requirements of 025 Pa Code § 96.8 have been met, and how the credits will be generated by the PRA, including calculations, assumptions, and photos.
  - B. A map(s) illustrating the locations of the proposed PRA (conservation plan, Ag E&S, NMP, or topographical maps are acceptable). Associated documentation should include latitude and longitude coordinates for each PRA (coordinates of the centroid of each PRA area/location).
  - C. Details on the timing of credits, such as the timing of credit generation and delivery, timing of a phase-in period, and the time frame for sale and use of credits toward permit effluent limits.
  - D. The water quality uses under Chapter 93 (relating to water quality standards), and any applicable impairment listings under section 303(d) of the Federal Water Pollution Control Act (33 U.S.C.A. § 1313(d)), for the receiving stream segment nearest the location of the proposed pollutant reduction activity. Identification of the water basin of which that receiving stream is a part should also be included. The Nutrient Trading GIS App ([www.depgis.state.pa.us/NutrientTrading](http://www.depgis.state.pa.us/NutrientTrading)) can be used to determine all of this information.
  - E. Information on sources of funding used to pay for any portion of the pollutant reduction activity, including the dollar amount and any conditions and restrictions regarding the use of the funds toward the generation or sale of credits.
  - F. A description of how risks of failure of the pollutant reduction activity will be managed, such as the use of financial guarantee mechanisms, contractual arrangements, insurance products or reduction of the concentration of projects in a particular sub-watershed.
  - G. A description of preservation and conservation easements on lands where the pollutant reduction activity is to be implemented.
  - H. Identification of notations or documents submitted in the request which the person submitting the request claims to be confidential business information or a protected trade secret protected from disclosure by law, and a justification for the claims. Any confidential information must be in a separate document(s).
    - I. The name of the person submitting the request and the names of the participants involved in the pollutant reduction activity.
    - J. The professional qualifications of the persons who completed the calculations and verification plan, conducted the baseline and threshold determinations, or otherwise contributed to the technical merits of the request.
    - K. A verification plan describing the methods that will be used for credit verification, such as the documentation of the implemented pollutant reduction activity that will be submitted, sufficient to allow verification that the pollutant reduction activity in the certification was properly implemented during the applicable compliance period. The verification plan must include self-verification by the person responsible for implementing the pollutant reduction activity or third-party verification, and is subject to approval by the Department of Environmental Protection (DEP).
