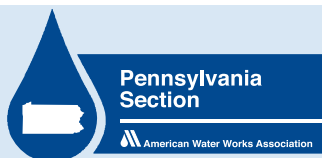

#### WHAT IS AWOP?

The Area Wide Optimization Program (AWOP) is a collaboration of 22 states, the U.S. Environmental Protection Agency and the Association of State Drinking Water Administrators. Its goal is to encourage water plants to go beyond what is legally required and produce the best water quality possible. That includes submitting more water quality data than required, and analyzing that data to find deficiencies.

The top performing filter plants in PA were honored at recent water conferences. The *Partnership* members that received AWOP Awards were: Blossburg, Shenandoah, Greencastle, Forest Park, Allentown, Highland, Lewistown, Harrison Twp, Westmoreland, and Waynesboro.

# Two More Facilities Begin Phase III Report

The *Partnership for Safe Water* Program is pleased to note that two additional Pennsylvania public water supply systems, Northampton Borough Municipal Authority and Western Berks Water Authority, have recently begun writing their Phase III self analysis reports utilizing the Pennsylvania Partnership Password Protected Program.

The PA-AWWA section and City of Allentown Water Filtration Plant Personal have developed a Password Protected Questionnaire Assistance Program intended to enlist and assist water treatment plant Operators in completing the Phase III portion of the *Partnership for Safe Water* Program entitled "Self-Assessment and Peer Review". The Questionnaire is intended to complement the recently released Self-Assessment Template (S-AT), the AWWA-RF document "Self-Assessment Guide for Surface Water Treatment Plant Optimization" (S-AG) and example report, which can be found on the AWWA web site, [www.AWWA.org](http://www.AWWA.org)

Experience gained from systems recently utilizing the Questionnaire has revealed that individual password protected responses,

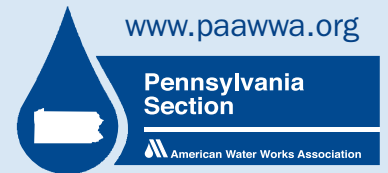

coupled with monthly organization meetings has resulted in a collective response in which all operators have truly participated. Additional experience has shown merit in setting up "teams" that are given responsibility for coordinating a response to identified "problems", also known as performance limiting factors and providing "recommendations", known as action plans. These responses are presented by the teams to the group in follow up meetings, discussed and fine-tuned if necessary and incorporated in the appropriate section of the Report. Typically when the Questionnaire is completed the Phase III Report can be finalized utilizing the collective response of all Operators, along with the appropriate data assembled in the Appendices, as identified in the checklist, the Report can be submitted for peer review through AWWA.

The Password Protected Questionnaire is just one of a number of tools available to Pennsylvania's *Partnership* members, providing assistance in completing the various Phases of the Program and, maybe more importantly, assisting operators in optimizing their operations. Please contact your *Partnership* representative to discuss and try out these new tools.

## Excel 2007 May Need Adjustment

Several Partnership members have experienced difficulty using the Partnership's data collection software with Microsoft Excel 2007. If you are using Excel 2007, please follow the instructions below to avoid problems processing data using the *Partnership* software. YOUR MACRO SETTINGS MAY NEED TO BE CHANGED.

- After opening the data collection software, you may see a message right below the toolbar that says: "Security Warning - macros have been disabled"
- Select the "options" button located in this message
- Select "Enable this content"
