Instructions:

A Certification Form for a Chapter 105 General Permit Registration submitted through DEP's e-permit system **must be completed foreach submission made in e-permitting**. This form must contain the project specific information for each registration submitted. The Certification form is to be signed by the Owner/Applicant, See Section B. Instructions.

Sections A. Applicant (Owner) & Project Information:

Please fill in the requested information to identify the applicant (owner) and project. **This information must match the information inthe e-permit submission.**

Section B. Certification:

Please sign, indicate title and date in the appropriate locations. The Registration will not be accepted unless the form is signed and dated by the applicant/owner. An applicant may choose to either physically sign, scan, and upload (i.e. "wet signature") or electronically sign and upload this certification form (such as signing this form PDF with third party signature verificationsoftware) to the Department, consistent with the Electronic Transactions Act of 1999 (73 P.S. §§ 2260.101 - 2260.501).

Clarification on applicant/owner signature:

Individual – The Registration form must be signed by all owners listed within the deed of the property or lease/rental agreement withtheir original signatures. *For Individual(s)*, *no indication of title is necessary*.

Corporations – The Registration form must be signed by the President or Vice President, Attested by the Secretary (Assistant Secretary) or Treasurer (Assistant Treasurer).

If others are signing on behalf of the corporation, a document evidencing delegation of contracting authority must be provided. Acceptance of the delegated documentation is at the sole discretion of DEP. Absent satisfactory documentation of signatory authority, only the above officers will be accepted as appropriate signatories.

Government agencies – The Registration form must be signed by the Chief Officer or the President/Vice President of the governmentagency, if incorporated. Chief Clerk, Secretary or Treasurer Signature is required to witness or attest.

Partnerships – The Registration form must be signed by either one general partner to bind the partnership or all partners must sign. For Limited Partnerships (LP), where each individual is a general partner, any general partner may sign. If a corporation is a general partner, the signage must 1) indicate the name of the corporation, 2) that it is a general partner, and 3) the signature of the President orVice President *and* the signature of the Secretary or Treasurer.

If others are signing on behalf of the Limited Partnership, a document evidencing delegation of contracting authority must be provided. Acceptance of the delegated documentation is at the sole discretion of DEP. Absent satisfactory documentation of signatory authority, only the above officers will be accepted as appropriate signatories.

Limited Liability Companies – The Registration form must be signed by a member for a Limited Liability Company (LLC), where it is manager managed; where it is manager managed, a manager must sign. Please indicate whether the person is signing as a "Member" or as a "Manager" of the LLC, according to the Company's Limited Liability Company Operating Agreement.

If anyone other than a "Member" or "Manager" are signing on behalf of the LLC, documentation of authority to sign on behalf of the LLCmust be provided.
