Delaware Estuary Coastal Zone

14.PD.01: "Delaware Estuary Coastal Zone Management Implementation Program"

Delaware Valley Regional Planning Commission will use a \$50,000 grant to implement the Coastal Management Program in the Delaware Estuary Coastal Zone that includes Delaware, Philadelphia and Bucks counties

14.PD.02: "Southeastern Pennsylvania Coast Day 2015"

Partnership for the Delaware Estuary, Inc. will use a \$35,725 grant to conduct Pennsylvania Coast Day 2015 events, which educate the public about coastal recreation, historic sites and public access

14.PD.03: "Schuylkill Banks Trail & Greenway: Bartram's to Passyunk Point Planning"

Schuylkill River Development Corporation will use a \$45,000 grant to perform a feasibility study and develop preliminary design for an extension of Schuylkill River Trail from south of Bartram's Garden to south of Passyunk Avenue

14.PD.04: "Croydon Woods Stewardship and Management Plan"

Heritage Conservancy will use a \$11,467 grant to develop a comprehensive management and stewardship plan for Croydon Woods

14.PD.05: "Crozer Park to Deshong Park Recreational Trail Design"

City of Chester will use a \$32,500 grant to plan, survey and design a recreation trail connecting Crozer Park to Deshong Park in the City of Chester

14.PD.06: "Tacony/Wissinoming Connector Street Feasibility Study"

Delaware River City Corporation will use a \$45,000 grant to fund a planning study for a neighborhood green connector street connecting the Wissinoming and Tacony neighborhoods in Philadelphia to Lardner's Point Park and the East Coast Greenway

Clean Air Council will use a \$30,000 grant to fund preliminary design of the Cobbs Creek Connector Trail Segment B

Friends of Silver Lake will use a \$10,100 grant to continue to monitor the watershed and educate high school students on non-point source pollution, invasive species and other coastal issues

14.PD.09: "Schuylkill Banks Youth Kayak Program"

Schuylkill River Development Corporation will use a \$2,240 grant to provide urban youth free aquatic recreational experiences on the Schuylkill River

14.PD.10: "Stewarding Bristol Marsh"

eritage Conservancy will use a \$18,000 grant to restore and steward Bristol Marsh Preserve and Mill Creek through educational programs and clean-up days

14.PS.04: "Marine Highway Analysis"

Philadelphia Regional Port Authority will use a \$40,000 grant to analyze the feasibility of a marine highway project between the Port of Philadelphia and selected port pairings on the M-95 corridor

Pennsylvania Historical and Museum Commission will use a \$43,000 grant to implement the Cultural Landscape Treatment Plan at Pennsbury Manor

Lake Erie Coastal Zone Projects

14.PE.01: "Lake Erie Coastal Zone Coordination & Technical Assistance"

County of Erie will use a \$74,000 grant for coordination and technical assistance with Lake Erie Coastal Zone projects

14.PE.01A: "Lake Erie Coastal Zone Administration of Bluff Recession Setback Act"

County of Erie will use a \$9,000 grant to assist Lake Erie coastal communities in administering the Bluff Recession and Setback Act of 1980

14.PE.02: "The Missing Link: A National Weather Service Buoy for the Pennsylvania Waters of Lake Erie"

Regional Science Consortium will use a \$25,000 grant to collect additional weather and wave data to complete an existing observation system which will provide safety information for boaters on the Pennsylvania portion of Lake Erie
