Partnership for Safe Water Data Collection Software Upgrade

The new data collection software upgrade (version 3.1) for the Partnership for Safe Water is now available. Version 3.1 replaces the previous version 2.1, and will be provided by mail to all Partnership members.

This is the software that is used to submit your annual report data. A printed copy of the statistics table page with the turbidity, and probability distribution graphs must also accompany your Phase III completion report. The data outputs are identical to the previous version.

Version 3.1 contains numerous improvements to make data entry more efficient. Remember that there are two files to save: the

entire workbook that includes all of your data, the statistical table and graphs; and the "save file for AWWA" which is only a statistical table and all you need to send in for your annual report.

Please use the new version to enter and submit your data this year. You will find it easier and more trouble free. If, however, you have already completed your data entry using the version 2.1 you can submit this as your annual report data.

55th Annual Conference PA Section — AWWA

The PA Section – AWWA held its 55th Annual Conference in May at the David L. Lawrence Convention Center, in Pittsburgh, PA. At the Opening General Session, Chair Deb Lippert presented the Partnership for Safe Water Report, in which she acknowledged Oakmont Water Authority as a recipient of the Water Drop Achievement Award for completing Phase III of the partnership program. By completing Phase III, the Oakmont Water Authority is working to provide an additional measure of protection to drinking water consumers.

In attendance were Edward Adams, Water Production Superintendent who accepted the award on behalf of the authority, and John Dunlap, General Manager. Oakmont presently provides drinking water service to over 39,000 people through approximately 16,000 residential, commercial and industrial connections in Allegheny County.

Why optimize performance through the Partnership Program?

It is important to keep in mind that the purpose for optimizing filter plant performance is to provide an additional measure of safety to reduce the risk of waterborne disease outbreaks. Research indicates that when filter effluent turbidity ranged between 0.1 and 0.3 NTU, Cryptosporidium presence was as much as 90 percent greater than when filter effluent turbidity was optimized at 0.1 NTU or less. The Partnership program's self-assessments identify areas that will enhance your water system's ability to prevent entry of Cryptosporidium, Giardia and other microbial contaminants into the treated water. At the same time, you can voluntarily make corrections that are appropriate for your water system.

Mentoring Program

PA-AWWA and PADEP are considering developing and coordinating a "Mentoring Program" for the Partnership for Safe Water. Mentoring provides an opportunity for filter plant staff who have been involved in the Phase III self-assessment to help other operators who are currently working toward Phase III completion. The focus of this assistance would be to share Partnership experiences, operational knowledge gained, and tips and hints on working through the Phase III process.
