### Kittanning Suburban Joint Water Authority



### Claricone system helps Kittanning maintain low turbidity levels

Recent upgrades to the Kittanning Suburban Joint Water Authority's treatment process are aiding the water system's goal of reaching Phase III of the Partnership for Safe Water program.

Kittanning installed a claricone, which uses centrifugal force to separate and remove solids from the water, thus reducing turbidity prior to filtration. The claricone is 30 feet high, holds 150,000 gallons and has a five hour detention time when running at 500 gpm.

The Kittanning Suburban Joint Water Authority's water treatment plant, located in the Tarrtown area of East Franklin Township, provides water to residents in northwestern Armstrong County including Cadogan, North Buffalo, East Franklin, Washington and Sugarcreek townships.

The upgrades have increased the plant's capacity from 800,000 gallons to 1.2 million gallons per day. The plant operates at 50 percent of its capacity. Everything at the plant is now more state-of-the-art, more high-tech and computer controlled.

The Authority was established in 1968. The plant, using water from the Allegheny River, was built in 1992, and serves 2,600 customers. Kittanning Suburban joined the Partnership for Safe Water program in September 2000 under the direction of Richard

### Partnership for Safe Water Phase III Questionnaire:

*Certain limiting factors came to light and were able to be recognized, and talked through amongst operators. All agreed upon solutions and SOP changes were instituted.*

3. The quality of the plant effluent has improved? Explain.

*Yes, SOP changes to meet <0.1 NTU have improved plant effluent quality.*

4. Your plant is now at or near optimization? Near.

5. The time invested in the self-assessment was well worth the effort? Explain.

*Definitely, involvement by all levels of management and staff*

*proved to be an education to all. A better overall understanding of the entire process and capability of each unit process was obtained.*

In a paragraph or two, please state why you would recommend to other WTP's, that have completed Phase II, that they should proceed to completion of Phase III of the PfSW program.

*Phase III coerces you, at all levels of staffing, to evaluate, in detail, the capabilities of your treatment plant. Simple changes to SOP's without capital costs can be implemented to improve overall water quality. By acknowledging limiting factors, changes can be made to eliminate complacency and correct inadequacies resulting from sub par past practices ("...because we always did it that way...." responses). A definite worthwhile time commitment that can show immediate returns in improving water quality.*

### Partnership for Safe Water Program Representative Wanted

The Pennsylvania Section of the American Water Works Association (PA-AWWA) is seeking a representative for the Partnership for Safe Water program (PfSW). The PfSW focuses on optimizing the operation of water filtration plants and is supported by both the Pennsylvania Department of Environmental Protection (DEP) and the Section. The representative will visit surface water filtration plants in the north-west and north-central portions of the Commonwealth. The representative's primary objective will be to provide technical assistance and training (e.g. report writing and computer software) to systems working through the Partnership's Phase III Self-Assessment process. ## Pennsylvania American Water Receives National Award for Ongoing Safe Water Practices

Pennsylvania American Water recently received national awards for maintaining the Partnership for Safe Water's Directors Award requirements at nine filter plants for five consecutive years.

The Director's Award is presented to water systems that have successfully completed a rigorous review in the Partnership's Self-Assessment and Peer Review phase. During this phase, participating utilities identify areas of possible improvement in plant design, operation and management and then create a plan for implementing these improvements.

To receive the five-year award, utilities must carry out these improvements and deliver water that not only meets drinking water standards, but also surpasses what is required by regulation, for five consecutive years.
