The SPOTLIGHT is on: City of Easton Water Treatment Plant



Easton became a member of the Partnership for Safe Water program in 2006 as an ongoing effort to demonstrate the desire to optimize the water treatment facilities for their continuously expanding service area. The Easton Water Treatment Plant provides service for a population of more than 90,000 and is located in Northampton County. Through the cooperative efforts of the City of Easton and the Easton Suburban Water Authority, an agreement was reached to operate the Water Treatment facilities under the direction of the Easton Suburban Water Authority. Guidance in both technical and administrative capacities was contracted with Miller Environmental, Inc., of which Charles Wilson and John Bartol are a part.



As part of the Partnership for Safe Water incentive to assist utilities moving forward to Phase III, PfSW representative Bob Donnelly recently visited the Easton Water Treatment Plant to present "Introduction to the Partnership for Safe Drinking Water". Following the presentation the Easton Water Treatment Plant's

Superintendent, Chuck Wilson, John Bartol and Patricia Hann employees of Miller Environmental, Inc and Donald Mauro, Joseph McDonald, Robert Piro, and George Frew, employees of Easton Suburban Water Authority, completed the Partnership for Safe Water (PfSW) Contact Hour Qualification Quiz with the result of 100% to receive 2.0 PA DEP Contact Hours.

Chuck, John, and Don have been instrumental in getting the plant staff involved with the rigorous task of the self-assessment portion of the Phase III report. John has implemented a computer program (designed by a former colleague Mr. George Lill) to enable the staff to systematically evaluate the entire plant, process- by- process, to work toward optimization of the Easton Treatment Plant. While John will remain the coordinator of the effort – the involvement of the entire staff is where the real benefit is derived. The Partnership Phase III self-assessment is a valuable tool for both veteran and newer employees, of all plant disciplines, to evaluate the way they do things and to look for possible changes to make their operation more effective and efficient.




New membrane filtration Section

The North Wales Water Authority, along with the North Penn Water Authority, announced the completion of the Plant Expansion Project at the Forest Park Water Treatment Plant. The dedication ceremony and plant tour was held on Thursday, October 4th. In addition to the tour, there was a brief presentation that describes the treatment process and the nature of the expansion project.

Forest Park originally opened in 1994 as a joint project between both water authorities in response to the need for a reliable, high quality, long-term source of surface water supply for the growing communities in Montgomery and Bucks Counties. Forest Park

New Partnership Tools and Program Enhancements

There is a new tool on the Partnership website that may help you prepare your Phase III completion report. It is a Phase III Self-Assessment Report Template posted for download on the website. www.awwa.org.

The Phase III Template was developed by Ed Chescattie, Water Treatment Plant Program Specialist with PA DEP and PfSW Representative Bob Donnelly and approved by the Program Effectiveness Assessment Committee (PEAC). This accomplishment was highlighted in the National Partnership for Safe Water Newsletter. Many of Pennsylvania's water systems are currently using the Template as an aid to writing their Phase III Report and have indicated that it has helped in compiling, organizing, and completing their work. Once the Template is completed, and the information outlined in the checklist is collected, the document will be ready to be submitted for review.

Annual Reports Overdue

Your annual report for the period 6/1/2006 – 5/31/2007 was due in June. Guidelines for annual reports are found on the Partnership website (www.awwa.org). You must use V3.1 (or later) of the data collection software to submit your data.

E-mail Annual Report Next Year!

NO more floppy discs. NO more CDs and NO DVD'S. Annual report data must be sent to us via e-mail. The Partnership Steering Committee approved this policy to speed communication and reduce cost.

"Most utilities already send in their annual reports using e-mail," says Debby Qualls, Partnership Coordinator. "There is only a few that still use the postal service to deliver data discs. It's time to end this practice so that everyone can benefit."

All participating plants must now submit their annual report data (and the narrative for award-winning plants) by e-mail. If you have any questions contact Debby, dqualls@awwa.org.

NOTICE

All participating plants must include a statement of conformance with regulations in their annual report. If you receive a Notice of Violation you must explain the situation and send us a copy of the Notice.
