#### First aid measures

Eye contact

: In case of contact, immediately flush skin with plenty of water for at least 15 minutes while removing contaminated clothing and shoes. Wash clothing before reuse. Clean shoes thoroughly before reuse. Get medical attention immediately.

Inhalation

# Accidental release measures

Personal precautions

Do not touch or walk through spilled material. Avoid breathing vapor or mist. Provide adequate ventilation. Wear appropriate respirator when ventilation is inadequate. Methods for cleaning up

Small spill

: Stop leak if without risk. Move containers from spill area. Absorb with an inert material. Dispose of via a licensed waste disposal contractor.

#### Accidental release measures

Large spill

: Stop leak if without risk. Move containers from spill area. Approach release from upwind. Dike spill area and do not allow product to reach sewage system or surface or ground water. Notify any reportable spill to authorities. (See section 12 for environmental risks and 13 for disposal information.) Contain and collect spillage with noncombustible, absorbent material e.g. sand, earth, vermiculite or diatomaceous earth and place in container for disposal according to local regulations (see section 13). Dispose of via a licensed waste disposal contractor. Contaminated absorbent material may pose the same hazard as the spilled product. # 7. Handling and storage

Handling

: Put on appropriate personal protective equipment (see section 8). Eating, drinking and smoking should be prohibited in areas where this material is handled, stored and processed. Sodium molybdate is a component of this product. Abnormal liver function tests have occurred in workers exposed to molybdenum compounds. Biochemical changes may predispose workers to gout (a severe arthritic condition brought on by the bodies inability to metablolize blood uric acid).
