Dear Permittee:

In accordance with your request received on October 21, 2024, the Department of Environmental Protection (DEP) has transferred a total of fifty-three (53) Water Quality Management (WQM) permits to the Pennsylvania American Water Company. A list of the WQM permits being transferred and their original issuance date is attached. This list will serve as documentation of transfer rather than creating an individual permit-document for each project. All conditions, supporting documentation and addendums of those permits are also made part of these transfers.

Any person aggrieved by this action may appeal the action to the Environmental Hearing Board (Board), pursuant to Section 4 of the Environmental Hearing Board Act, 35 P.S. § 7514, and the Administrative Agency Law, 2 Pa.C.S. Chapter 5A. The Board's address is:

IF YOU WANT TO CHALLENGE THIS ACTION, YOUR APPEAL MUST BE FILED WITH AND RECEIVED BY THE BOARD WITHIN 30 DAYS OF RECEIPT OF NOTICE OF THIS ACTION.
