Purpose of Application Application for a renewal of an NPDES permit for discharge of treated sewage.

Internal Review and Recommendations

The first draft of this application appeared in the PA Bulletin on Saturday, February 16, 2019. The final NPDES permit could not be issued due to open violations.

There are still two open violations for the client/facility in the Clean Water Program:

1. 02/15/2023 - Violation ID 985192 – Violation Code 92A.44 – NPDES - Violation of effluent limits in Part A of permit.
2. 02/15/2023 - Violation ID 985193 – Violation Code 92A.61(C) – NPDES - Failure to monitor pollutants as required by the NPDES permit.

A new DRBC Docket has come into effect since the first draft NPDES Permit has been issued. DRBC Docket NO. D-2006-020-4 has an approval date of December 8, 2021 and expiration date of December 2, 2026. This docket requires monthly monitoring/reporting for Nitrate as N or Nitrate + Nitrite as N and also monthly monitoring/reporting for Total Nitrogen or Total Kjeldahl Nitrogen.

Therefore, the annual monitoring and reporting for Nitrate-Nitrite as N, Total Nitrogen, and Total Kjeldahl Nitrogen were replaced with monthly monitoring and reporting. The annual monitoring for Total Phosphorus was removed because there are already limitations required for Total Phosphorus.

Sewage discharges now require monitoring and reporting for E. Coli. A monitoring frequency of 1/month for design flows \geq 1 MGD, 1/quarter for design flows \geq 0.05 and $<$ 1 MGD, 1/year for design flows of 0.002 – 0.05 MGD will be utilized.

All the permit documents have been updated to the newest format.
