Internal Review and Recommendations

The first draft of this application appeared in the PA Bulletin on Saturday, January 19, 2019, and the second draft of this application appeared in the PA Bulletin on January 18, 2020. The final NPDES permit could not be issued due to open violations.

There is still one open violation for the client/facility:

- 01/30/2020 - Violation ID 876794 – Violation Code 92A.41(A)4 – NPDES - Failure to take all reasonable steps to minimize or prevent any discharge or sludge use or disposal in violation of a permit.

A third draft of the NPDES permit is being issued because 6 months (or 180 days) have elapsed since the second draft has been issued.

Re-modeling was not performed. Limitations and monitoring frequencies have been carried over from the second draft.

Sewage discharges now require monitoring and reporting for E. Coli. A monitoring frequency of 1/month for design flows \geq 1 MGD, 1/quarter for design flows \geq 0.05 and $<$ 1 MGD, 1/year for design flows of 0.002 – 0.05 MGD will be utilized.

All the permit documents have been updated to the newest format. The contact information for the client and facility has also been updated.
