Internal Review and Recommendations

The first draft of this application appeared in the PA Bulletin on Saturday, February 15, 2020. The final NPDES permit could not be issued due to open violations.

There are still three open violations for the facility:

1. 10/07/2020 - Violation ID 896443 – Violation Code 92A.41(A)8 – NPDES - Failure to provide information or records required by the permit or otherwise needed to determine compliance.
2. 05/24/2021 - Violation ID 919722 – Violation Code 92A.44 – NPDES - Violation of effluent limits in Part A of permit.
3. 05/24/2021 - Violation ID 919723 – Violation Code 91.21 – CSL - Failure to apply for and/or obtain a WQM permit for the construction of sewage or industrial waste facilities.

A second draft of the NPDES permit is being issued because 6 months (or 180 days) have elapsed since the second draft has been issued.

Re-modeling was not performed. Limitations and monitoring frequencies have been carried over from the first draft.

Sewage discharges now require monitoring and reporting for E. Coli. A monitoring frequency of 1/month for design flows >= 1 MGD, 1/quarter for design flows >= 0.05 and < 1 MGD, 1/year for design flows of 0.002 – 0.05 MGD will be utilized.

The permit is being transferred from Bennocos Beef & Brew Inc (Client ID 252687) to R Place on 590 (Client ID 354676).

WQM Permit 6403401 T-2 will be transferred with the final NPDES Permit. A “T-2” notation has been added after the WQM permit to represent the number of transfers since the original permit was issued.

Internal Review and Recommendations

An "A-2" notation has been added after the NPDES permit to represent the number of transfers since the original permit was issued.
